#### Sir/Madam

I am directed to refer to this Ministry's letter of even number dated 19.08.2014, 09.10.2014 and 16.01.2015 on the above mentioned subject and to say that the revised time-lines for filing of declaration of assets and liabilities returns in the revised forms, under section 44 of the Lokpal and Lokayuktas Act, 2013, by all public servants are as follows:-

- (i) The first return under the Lokpal Act (**as on 1**<sup>st</sup> **August, 2014**) [as was initially required to be filed by 15<sup>th</sup> September, 2014] can now be filed **by15**<sup>th</sup> **October, 2015**.
- (ii) The annual return (**as on 31**<sup>st</sup> **March, 2015**) [as was initially required to be filed by 31<sup>st</sup> July, 2015] can now be filed by **15**<sup>th</sup> **October, 2015**.
- (iii) The **subsequent annual returns** (as on 31<sup>st</sup> March of every year) are required to be filed **by 31<sup>st</sup> July of that year**.
