The interested Bidders may submit their bid application alongwith an Earnest Money Deposit of Rs.5,000/- (Rupees Five Thousand Only) by way of Demand Draft/Pay Order in favour of "Pay & Accounts Officer, Ministry of Tourism, New Delhi". The quotations/tenders received without Earnest Money Deposit (EMD) will not be considered and shall not be accepted by this Ministry. The bidders shall have to bid separately for items at Proforma I and II.
- 4. The quotations received in time will be opened in the Room No. 130 of Under Secretary (Admn.IV), Ministry of Tourism, Transport Bhawan, New Delhi at 3:00 PM on 8.11.2019. The Bidders or their representative (not more than one) may be present, if they so desire at the time of opening of quotations.
- 5. The auction will be governed by the following conditions:
