DEVELOPMENT OF TOURISM INFRASTRUCTURE IN BIHAR

DR. MOHAMMAD JAVED:

Will the Minister of TOURISM be pleased to state:

- (a) the details of the funds sanctioned by the Government and the amount utilized for development of tourism infrastructure in the country with specific reference to Bihar and Telangana during the last five years, scheme and year-wise;**
- (b) the total number of tourist sites for which development works have been done during the above period in the country including Bihar and Telangana;**
- (c) the details of the number of foreign tourist arrivals in the country during the said period, State/UT-wise and their growth figure; and**
- (d) whether the Government has prepared any comprehensive roadmap to develop tourism infrastructure across the country especially in States like Bihar and Telangana having abundant tourism potential and if so, the details thereof?**

ANSWER

(a) to (d): The Ministry of Tourism, under the schemes of Swadesh Darshan, PRASHAD and Assistance to Central Agencies, provides Central Financial Assistance to State Governments/Union Territory (UT) Administrations/Central Agencies for development of thematic tourist circuits in the country, for holistic development of identified pilgrimage and heritage destinations and for the development of tourist infrastructure at destinations owned by the Central Agencies.

The projects under the above schemes are identified in consultation with the State Governments/UT Administrations/Central Agencies and are sanctioned subject to their adherence to relevant scheme guidelines, submission of suitable Detailed Project Reports, availability of funds and utilization of funds released earlier.

Based on the above, the details of projects sanctioned by the Ministry under the above schemes for development of tourism-related infrastructure in the country including the States of Bihar and Telangana during the last five years is given at Annexure I.

The Foreign Tourist Arrivals (FTAs) in the country during the years 2014 to 2018 alongwith the corresponding year on year growth rates are as below:
