- 3. Phrases like "no change" "no addition" or "as in the previous year" should not be used and full details to be provided.
- 4. It is pertinent to mention that as per the instant instructions of DoP&T issued vide its OM No. 22-10/2018-CS 1(APAR) dated 29.09.2011, "vigilance clearance shall be denied to an officer if he/ she fails to submit his/her annual immovable property return of the previous year by 31st January of the following year.
- 5. The said return should reach the Vigilance Division on or before 31st January, 2019, for taking further necessary action. It may be noted that defaulting officers will not be granted vigilance clearance for deputation foreign training, empanelment etc.
