- (a): The Ministry of Tourism under Swadesh Darshan Scheme has sanctioned projects related to infrastructure development covering various themes including 'Ramayana' and 'Buddhist'. The details of the projects sanctioned under Ramayana and Buddhist circuits including projects sanctioned during the period 2017-2018, 2018-2019 and 2019-2020 is annexed. The projects are under various stages of implementation.
- The Ministry of Tourism plays a crucial role by providing financial assistance (b) to (d): the States / Union Territory Administrations (UTs) for development of tourism infrastructure undertaking promotional and marketing and by creating trained manpower resources domestic international markets and through its various schemes. Allocation and utilization of budget and target achieved under different schemes is dependent on several factors including past performance, the stages of formulation/implementation of various schemes, the institutional capacity of the implementing agencies to implement the scheme as scheduled, the quantum ofGovernment assistance with the recipients unutilized lying
