2395. SHRI IRANNA KADADI:

Will the Minister of **TOURISM** be pleased to state:

- (a) the average revenue generated and foreign exchange earned from tourism during the last three years;
- (b) The details of the ongoing schemes for the development and promotion of tourism and the number of tourism infrastructure projects prioritised/sanctioned during the above period, particularly in Karnataka, State/ UT-wise;
- (c) whether Government has received proposals from various States for the development and promotion of tourism and allocation of funds therefor; and
- (d) if so, the details thereof indicating the number of such proposals received and the number of projects sanctioned and funds allocated, State-wise?

ANSWER

(a): Ministry of Tourism, Government of India does not maintain data on revenue generated from tourism. Further, the details of Foreign Exchange Earnings (FEE) through tourism during 2017 to 2019 are given below:

(b), (c) & (d): Development and promotion of tourism is primarily the responsibility of the concerned State Government/Union Territory Administration. However, Ministry of Tourism promotes India as a holistic destination and as part of its on-going activities, releases domestic and international print, electronic and online media campaigns to promote various tourism destinations and products in the different States and UTs of the country. These promotional activities are undertaken by the Ministry under its schemes of (i) Domestic Promotion and Publicity including Hospitality for promotion of Domestic Tourism, and (ii) Restructured Scheme of Overseas Promotion and Publicity including Marketing Development Assistance to promote Indian tourism in Overseas Market.

Further, Ministry of Tourism under its schemes of Swadesh Darshan, PRASHAD and Assistance to Central Agencies provides central financial assistance to State Governments/Union Territories/Central Agencies for development of tourism related

infrastructure and facilities. The projects under the schemes are identified for development in consultation with State Governments/UT Administration. The submission of the proposals by the State Governments/Union Territories under above schemes is a continuous process. The proposals are examined at various levels and approval are accorded to the proposals depending on the submission of suitable Detailed Project Proposals, Utilisation Certificate for the funds released to the Implementing agencies earlier, availability of funds, adherence to scheme guidelines which is also a continuous process. The details of the projects sanctioned under Swadesh Darshan and PRASHAD scheme are given at Annexure-I and Annexure-II respectively.
