**Subject : - Disposal of 250 KVA Full Load DG Set installed in C-1 Hutments – regarding.**

Ministry of Tourism proposes to dispose of One **250 KVA Full Load DG Set** as detailed at on “As is where basis”.

2. Accordingly, Quotations are invited for the disposal of the 250 KVA Full Load DG Set on the terms and conditions mentioned below. Persons/firms, interested in purchasing the above mentioned DG Set, may submit their highest quotations in the enclosed proforma addressed to the undersigned **latest by 12.00 PM on or before 20<sup>th</sup> July, 2021** after due inspection of the DG Set from July 05 to July 12, 2021. The quotations received in time will be opened at 02.00 PM on the next day i.e. on 21<sup>st</sup> July, 2021 in the Room No. 131, Transport Bhawan, New Delhi. The bidders or their representatives, not more than one for each quotation, may be present, if they so desire, at the time opening of Quotations. The cover should be prominently superscripted with the words “QUOTATION FOR PURCHASE OF 250 KVA Full Load DG Set”.
3. The tender documents can be downloaded on CPP Portal. The tender document is also available on Ministry of Tourism website: <http://tourism.gov.in>.
4. The envelope containing Technical and Financial Bids are required to be sealed properly, i.e. either wax or with adhesive cello tape on both ends. Rates quoted should be typewritten without cutting/overwriting. Unsigned and Unstamped bids in unsealed/stapled envelopes and bids without EMD( Earnest Money Deposit) shall not be accepted, except in the case of organization specifically so exempted.
5. As mentioned in Para (2) above, **the DG Set will be available for inspection from July 05 to July 12, 2021**. The agencies after due inspection may submit their quotation.
6. The Auction of DG Set will be governed by the following conditions:-
  - I. The bidders are required to pay Earnest Money of Rs. 5,000/- (Rupees Five Thousand Only) .
  - II. Earnest Money is payable by means of Demand Draft drawn in favour of Pay and Accounts Officer, Ministry of Tourism, New Delhi (Payment by cheque or cash shall not Be accepted).
  - III. Quotations received without demand draft towards Earnest Money will not be Considered and shall be rejected.

- IV. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favor of Pay & Accounts Officers, Ministry of Tourism, New Delhi within Two working days of the acceptance of the bid.
- V. The Earnest Money of the successful bidder will be released only after the deposit of the Bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if the firm/person fails to honour the bid.
- VI. The delivery of the auctioned DG Set will be arranged only after the successful bidder submits documentary evidence in support of residential status (Voter Identity Card etc., In case of individual and Registration Certificate etc., in case of firms).
- VII. The auctioned DG Set will be removed by the successful bidder within 02 working days of depositing the bid amount, at their own expenses.
- VIII. The DG Set will be disposed off on "as is where basis" and no guarantee for its worthiness or quality will be given by the Ministry.
- IX. No assistance/transportation will be provided by the Ministry. Permission to take out the disposed materials from the premises will not be allowed on holidays, Saturday and Sunday etc.
- X. Tender form should be signed in ink by the authorized signatory only. Photocopy of unsigned quotations/tenders or quotations/tenders not signed by the authorized signatory shall be rejected.
- XI. If the tendering firm/person furnishes any false or wrong information, they will be liable for consequences if any.
- XII. The Ministry reserves the right to reduce or increase the number of items offered. The undersigned also reserve the right to reject any bid assigning any reason. Auction document should be signed and uploaded by the bidder(s).
- X. The bidders will not be allowed to withdraw their bids and if they do so their earnest Money will be forfeited.
- XI. The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.
- XII. G.S.T @ 18% will have to be paid by the successful tenderer over and above his offer as per Govt. Rules.
