### APPROVED REVISED GUIDELINES FOR CHAMPION SERVICES SECTOR SCHEME (CSSS SCHEME) - INCENTIVE TO TOUR OPERATORS FOR ENHANCING TOURIST ARRIVALS TO INDIA

### 1. Introduction:

The Ministry of Tourism undertakes various promotional activities in source markets overseas to promote India as a tourism destination and to increase foreign tourist arrivals to the country. These activities are undertaken directly by the Ministry as well as through the overseas India Tourism offices.

2. The impact of the promotional activities has contributed towards steady growth in foreign tourist arrivals as well as foreign exchange earnings through tourism to the country. However, the list of the top source markets for Indian tourism has remained more or less constant, with some changes in inter-se positions.

3. In order to enhance India's share of foreign tourist arrivals vis-à-vis World Tourist Arrivals, the Ministry of Tourism (MoT), Government of India proposes to diversify its focus on promotion of India in Short, Medium and Long haul countries to tap the immense potential of these markets in augmenting high end tourist traffic to India and to encourage the tour operators from these countries to sell India tour programmes vigorously. The Ministry of Tourism under the CSSS Scheme of 'Incentive to tour operators for enhancing Tourist Arrivals to India' will extend financial incentives to Foreign Tour Operators (FTOs) of the countries tabulated below / Inbound Tour Operators approved by the Ministry of Tourism, Government of India, on a pilot basis. ### 4. <u>Eligibility Criteria:</u>

(i) Financial support under the Scheme would be available to Foreign Tour Operators (FTO) who are registered with the Government authority in their country of operation, <u>OR</u> Indian Inbound Tour Operator approved by the Ministry of Tourism, Government of India, who is working along with the FTO.

### 5. <u>Extent of Incentive</u>

- (i) The financial incentive will be available only to one agency only i.e. either the Foreign Tour Operator <u>OR</u> its Indian counterpart (Inbound Indian Tour Operator) approved by MOT for the same volume of tourists as indicated in the table above.
- (ii) The incentive amount of US\$ 30 / US \$ 50 per tourist in the case of Indian Inbound Tour Operator approved by the Ministry of Tourism, Govt. of India,

would be converted as per monthly Rate of Exchange adapted by Ministry of External Affairs, Govt. Of India for the month of submission of claim.

- (iii) The incentive will be disbursed by the Ministry of Tourism, Govt. of India, New Delhi, till such time Regional Director posts are filled up.

### 6. Terms & Conditions

- i. In order to avail the incentive, Prior Registration by the FTO/Indian Inbound Tour Operator is mandatory.
- ii. In the case of FTO, the application for Prior Registration for availing the incentive must be submitted to the respective India Tourism Office overseas at least one month before the commencement of the quarter (i.e. April to June / July to September / October to December / January to March), as per format at Annexure I.
- iii. In the case of FTO from Sri Lanka, and Inbound Indian Tour Operator approved by the Ministry of Tourism, the application for Prior Registration must be submitted to the Assistant Director General (Overseas Marketing), Ministry of Tourism, Govt. of India, Transport Bhawan, 1, Parliament Street, New Delhi 110 001 on email (New mail ID is being created)
- iv. The Prior Registration would have to be applied for between  $1^{st} 5^{th}$  of the preceding month of travel.
- v. The Prior Registration would be on first come first served basis and would be subject to availability of funds.
- vi. Prior Registration would be given only to one agency i.e either the Foreign Tour Operator or its Indian counterpart approved by the Ministry of Tourism.

# 7. Documents required for Prior Registration (to be submitted in pdf format by email only. Hard copy of documents will not be accepted):

- i. Self-certified copy of registration of the company with authority concerned in the country of its operation or Certificate of Approval of the Ministry of Tourism, Government of India in the case of Indian Inbound Tour Operator.
- ii. Declaration with official seal, date and on letter head of the company to the effect that the claimant is not under any investigation and/or has not been charged/prosecuted/debarred/ blacklisted by the Government authorities in the country of registration/Ministry of Tourism, Govt. of India/ Dept. of Tourism State Govt./UT Administration or any other Government agency (Annexure II).

**Note:** Prior Registration Approval will not ensure financial support under the Scheme. The same will be based on submission of claims complete in all respects by the applicant company and subject to availability of funds.

8. On completion of the quarter (i.e. April to June / July to September / October to December / January to March), the Foreign Tour Operator/Indian Inbound Tour Operator approved by MOT shall submit the application for availing the incentive in the prescribed format as per **Annexure III** within <u>30</u> days (thirty days), to the Assistant Director of the respective India Tourism Office, overseas listed at **Annexure IV**. The application would be examined and verified by the concerned India Tourism Office overseas and forwarded to the Ministry for necessary approval and disbursement of financial assistance. In the case of Inbound Tour Operator approved by the Ministry of Tourism, the application shall be submitted to the Assistant Director General (Overseas Marketing), Ministry of Tourism Govt. of India, Transport Bhawan, 1, Parliament Street, New Delhi 110 001 on email <u>csss.fta@gov.in</u>

8.1 In the case of FTO from Sri Lanka / Indian Inbound Tour Operator approved by MOT, the application for availing the incentive in the prescribed format as per **Annexure III** shall be submitted to the Assistant Director General (Overseas Marketing), Ministry of Tourism, Govt. of India, Transport Bhawan, 1, Parliament Street, New Delhi 110 001 on email <u>csss.fta@gov.in</u>

## 9. Documents required for claim of financial assistance (to be submitted in pdf format by email only. Hard copy of documents will not be accepted):

The Foreign Tour Operator / Indian Inbound Tour Operator approved by MOT will have to provide the following details in the company letterhead duly signed by the authorized signatory of the agency and the supporting documents:

- a) Name, address and contact details of the Foreign Tour Operator/Indian Inbound Tour Operator
- b) Copy of the Registration of tour agency/company registered with the Government authority in their country of operation (in the case of Foreign Tour Operator) / Certificate of Approval from the Ministry of Tourism, Government of India in the case of Inbound Tour Operator
- c) List of passengers sent to India during the particular quarter i.e. April to June / July to September / October to December / January to March, for which claim is submitted.
- d) Detailed itinerary along with dates and places of visit of the tourists.
- e) Copies of boarding passes for travel on the international sectors (country of origin to India)
- f) Copies of the first page of the passports and pages containing the entry stamps of Indian Immigration Authority as proof of travel from the country of origin to India.
