- 1. Due to prevailing circumstances of pandemic no pre-bid meeting provision was kept in Tender Document no TT/38/2020. As per the Tender Document in lieu of pre-bid meeting the opportunity has given to the interested bidders to send their queries for seeking clarification through e-mail latest by 20/09/2021(10 AM.)
- 2. Based on query raised with in stipulated time in prescribed format, followings are reiterated and clarified as per the clauses mentioned in the said Tender Document: -
- (i). Agencies are reiterated that the bid should be submitted online http://eprocure.gov.in/epublish/app strictly in accordance with the Tender Document within stipulated time frame as mentioned on portal and no offline bids will be accepted. Before submitting the bids, the bidders are advised to read the clauses of Tender Document carefully. Technical bids would be opened online as per the schedule specified on portal http://eprocure.gov.in/epublish/app.The Date and Time for opening of Financial Bids for qualified bidders will also be updated the on same portal i.e http://eprocure.gov.in/epublish/app.
- (ii). Bidders are exempted to submit EMD. Bidders are required to submit **Bid Security Declaration Form in prescribed format as mentioned in Annexure VI in lieu of** Earnest Money Deposit (EMD.
- (iii). The Firm / Agency should have a full-fledged establishment within India and an office with a dedicated team in Delhi-NCR. In this regard, It is required to be submitted a Self-certification on company's letter head signed by an authorized representative of the agency certifying that the agency has an office in Delhi-NCR.
- (iv). The soft copy of containing the information, as per the Technical Evaluation parameters are required to be submitted.
- (v). The specific requirement for the number of Full Time Equivalents(FTEs) to be engaged are as under: -

- A. Infoline/Helpline 50 Full Time Equivalent manpower including requirement of 40 Foreign languages and 10 English and Hindi Speaking.
 - (i) Tourist Info Line (TIL) / Helpline (Minimum one manpower to handle one specific foreign language at a time including one manpower each for English and Hindi.
 - (ii) Operation window: 24x7, 365 days in a year.
 - (iii) Offering a "multi-lingual helpdesk" in basic language i.e. Hindi and English with also qualified call agents conversant in International Languages namely Arabic, French, German, Italian, Japanese, Korean, Chinese, Portuguese, Russian, Spanish.
- B. Manning the Airport Counter- 49 Full Time Equivalent manpower to manning 10 Airport Counter. In future, additional Manpower may be required for the proposed Airport Counter at Ahmadabad.
