## Foreign Tourist Inflow to India October, 2021

Ministry of Tourism compiles monthly Foreign Tourist Arrivals (FTAs) on the basis of information received from Bureau of Immigration (BOI). The following are the important highlights regarding FTAs during the month of October, 2021.

## **Foreign Tourist Arrivals (FTAs):**

- FTAs in October, 2021 were 1,81,325 as compared to 41,494 in October,2020.
- FTAs during the period January- October, 2021 were 8,56,337 as compared to 25,83,245 in January- October, 2020 registering a negative growth of 66.9%.
- The percentage share of Foreign Tourist Arrivals in India during October 2021 among the top 15 source countries USA (26.44%) followed by Bangladesh (18.25%), UK (14.36%), Canada (6.69%), Nepal (3.94%), Sri Lanka (2.50%), Maldives (2.11%), Germany (2.06%), France (1.86%), Portugal (1.86%), Australia (1.07%) Italy (0.93%), Russian Federation (0.88%), Kenya (0.87%) and Korea (Rep.of) (0.84%)
- The percentage share of Foreign Tourist Arrivals in India during January-October 2021 among the top 15 source countries was highest from USA (26.59%) followed by Bangladesh (17.91%), UK (10.07%), Canada (4.75%), Nepal (4.75%), Afghanistan (4.24%), Portugal (1.98%), France (1.91%), Germany (1.86%), Maldives (1.72%), Iraq (1.39%), Sri Lanka (1.15%), Korea (Rep.of) (1.11%), Russian Fed (1.04%) and Japan (1.04%).
- The percentage share of Foreign Tourist Arrivals in India during October 2021 among the top 15 ports was highest at Delhi Airport (36.39%) followed by Mumbai Airport (12.99%), Haridaspur Land Check Post (9.94%), Chennai Airport (7.71%), Hyderabad Airport (5.96%), Bengaluru Airport (5.83%), Cochin Airport (4.77%), Ahmedabad Airport (4.12%), Kolkata Airport (2.87%), Gede Land Check Post (2.73%), Agartala Airport (1.45%), Amritsar Airport (1.28%), Trivandrum Airport (1.22%), Dabolim (Goa) Airport (0.89%) and Tiruchirappalli Airport (0.36%).
- The percentage share of Foreign Tourist Arrivals in India during January-October 2021 among the top 15 ports was highest at Delhi Airport (38.35%) followed by Mumbai Airport (12.97%), Haridaspur Land Check Post (10.22%), Bengaluru Airport (7.98%), Chennai Airport (7.52%), Hyderabad Airport

(5.53%), Ahmedabad Airport (4.44%), Cochin Airport (3.96%), Kolkata Airport (2.77%), Trivandrum Airport (0.94%), Amritsar Airport (0.85%), Agartala Land Check Post (0.67%), Gede Land Check Post (0.58%), Dabolim (Goa) Airport (0.48%) and Lucknow Airport (0.33%).
