#### 619 # SHRI NEERAJ DANGI:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government proposes to establish Government tourist centre for generating employment opportunities in the tourism sector;
- (b) if so, details of tourist centres established during the last three years, State-wise; and
- (c) the number of tourist places established by Government so far in the State of Rajasthan, the details thereof?

### ANSWER

### THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (c): Ministry of Tourism does not have any proposal for establishing Government tourist centre for generating employment opportunities in the tourism sector. However, the Ministry of Tourism has provided financial assistance to the States/UTs under the schemes of 'Swadesh Darshan' for the development of theme based tourist circuits and 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' for holistic development of identified pilgrimage destinations to give boost to the tourism sector and in turn generate employment opportunities in the country.

As per estimation in accordance with 3rd TSA, the contribution of tourism to employment of the country for year 2017-18, 2018-19 and 2019-20 is as follows:
