

Expression of Interest (EOI)
Consultancy Services for Tourism Track during India's G-20 Presidency

1. Invitation

- 1.1. Ministry of Tourism invites Expression of Interest from interested Consultants of **international repute and experience in providing services for such prestigious nature as G-20 Presidency.**
- 1.2. Interested Consulting Agencies having requisite capabilities may furnish their Expression of Interest with all the necessary documents at email roshanmthomas.dad@hub.nic.in and rk.bhati@nic.in on or before **27th August, 2022 by 16:00 hours IST**. The short-listed bidders will be invited for detailed presentation on 31st August 2022. No request for extension of time will be entertained.

2. Background

- 2.1. G20 is an intergovernmental forum comprising of 19 Countries & European Union (EU) which addresses the major issues of global economy such as International Financial stability, climate change mitigation and sustainable development. In 2023 the G-20 presidency will be taken over by India.
- 2.2. G-20 as an intergovernmental platform offers the opportunity for India to emerge as a key player and can bridge the developing and developed world. The priorities which India advocates should be taken as a G-20 priority. This requires the institutional memory and Organisational capital from the experiences of past presidencies.
- 2.3. Ministry of Tourism has been entrusted with the role of lead anchor for tourism track and will be responsible for setting priorities, deliverables and organizing tourism working group and tourism ministerial meetings during the course of India's G-20 Presidency.

3. Shortlisting of consulting agencies

Shortlisting of the consulting agencies submitting the expression of interest will be done based on their experience in undertaking similar tasks as given in the background above and indicative scope of work. The shortlisted agencies will be invited for detailed presentation by the Ministry of Tourism.

4. Indicative Scope of Work

Following is the indicative scope of work for the guidance of prospective consultant for submitting their expression of interest and the detailed scope of work, deliverables and milestone etc. will be finalized subsequently.

- 4.1. The Consultant shall assist the Ministry of Tourism in successfully discharging its mandate for G-20 Tourism working group:
- (i). Spear heading the priorities to logical deliverables. **Building of a narrative.**
 - (ii). Steer the working group - **Building up an agenda strategy**
 - (iii). Negotiations and derive consensus - **Building up an Implementation strategy.**
 - (iv). Content Coordination – **Creation of a favourable alignment across govts.**
- 4.2. The consultant shall guide the Ministry of Tourism in organizing tourism track based on their expertise in Tourism& International Co-operation and Experiences from past G20 or similarly placed International Platforms it had partnered with.
- 4.3. The consultant shall help TWG to frame overarching narratives, Issue notes, communique and presidency documents.
- 4.4. The consultant shall assist the Ministry of Tourism in steering negotiations and bringing out a consensus among member countries about the priorities, action plans and other deliverables
- 4.5. The consultant shall also help the Ministry in showcasing the capabilities of Tourism sector of India and thereby exposing the potential before the Investment community.
