Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has received any request from the State Government of Kerala seeking fund for infrastructure, tourism promotion and other related development in the tourism sector in the last two years;
- (b) if so, the details thereof and the response of Government thereto;
- (c) whether Government has given any fund to State Government of Kerala for the development in the tourism sector in the last five years; and
- (d) if so, the details of the fund allocated and utilised, section-wise and year- wise?

ANSWER

(a) to (d): Receiving proposals from the State Governments/UT Administrations/Central Agencies for financial assistance for tourism projects is a continuous process. The proposals received are examined with reference to the prescribed guidelines and financial assistance is extended for such projects subject to fulfilment of the stipulated conditions, operational viability and availability of funds.

The Ministry of Tourism has provided financial assistance to the State of Kerala under the 'Swadesh Darshan' & 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' Schemes for the development of tourism related infrastructure.

In addition, financial assistance has been provided to the State of Kerala for organizing fairs/festivals & tourism related events under Domestic Promotion & Publicity including Hospitality (DPPH) Scheme.

Ministry of Tourism has also sanctioned projects under the 'Assistance to Central Agencies for Tourism Infrastructure Development' Scheme for the development of tourism related infrastructure in the State of Kerala.

The list of projects sanctioned under the Swadesh Darshan, PRASHAD and Assistance to Central Agencies for Tourism Infrastructure Development Schemes as well as financial assistance provided for organizing fairs/festivals & tourism related events under DPPH Scheme to the State of Kerala is given at **Annexure**.
