SWADESH DARSHAN SCHEME

2227 SHRI DHANANJAY BHIMRAO MAHADIK:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government is progressing with Swadesh Darshan Scheme (SDS) for boosting tourism sector and if so, the details thereof;
- (b) whether Government has taken steps for development of tribal and rural circuits under the SDS and if so, the details thereof;
- (c) whether Government has received proposal from States of Maharashtra and Tamil Nadu for development of tourism circuits and if so, the details thereof and the response of Government thereto; and
- (d) whether all identified tourism circuits have been made operational and if so, the details thereof including the number of tourists participated in each circuit under the said Scheme?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) & (b): The Ministry of Tourism under its Swadesh Darshan Scheme (SDS) has sanctioned 76 projects for Rs.5399.15 crores for development of tourism infrastructure in the country. These sanctioned projects include Tribal and Rural tourism projects. The details of the projects sanctioned under Tribal and Rural themes is at annexure -I.

(c): The Ministry of Tourism has now revamped its Swadesh Darshan scheme as Swadesh Darshan 2.0 (SD2.0) in order to develop sustainable and responsible tourism destinations in the country with tourist & destination centric approach. The guidelines for Swadesh Darshan 2.0 scheme has been issued to all the States/Union Territory Administrations including Maharashtra and Tamil Nadu however no destination for development has been identified under Swadesh Darshan 2.0 scheme. The Ministry of Tourism has already sanctioned 2 projects in Maharashtra and 1 project in Tamil Nadu under Swadesh Darshan scheme, the details of which is at annexure -II.

(d): As per the information given by the States Governments/Union Territory Administrations, out of the total 76 sanctioned projects, 50 projects are now physically complete. The Ministry of Tourism is not maintaining the data in respect of the total number of tourists participating in each circuit, however the state wise domestic and foreign tourist visits during 2021 in the country is at annexure -III.
