

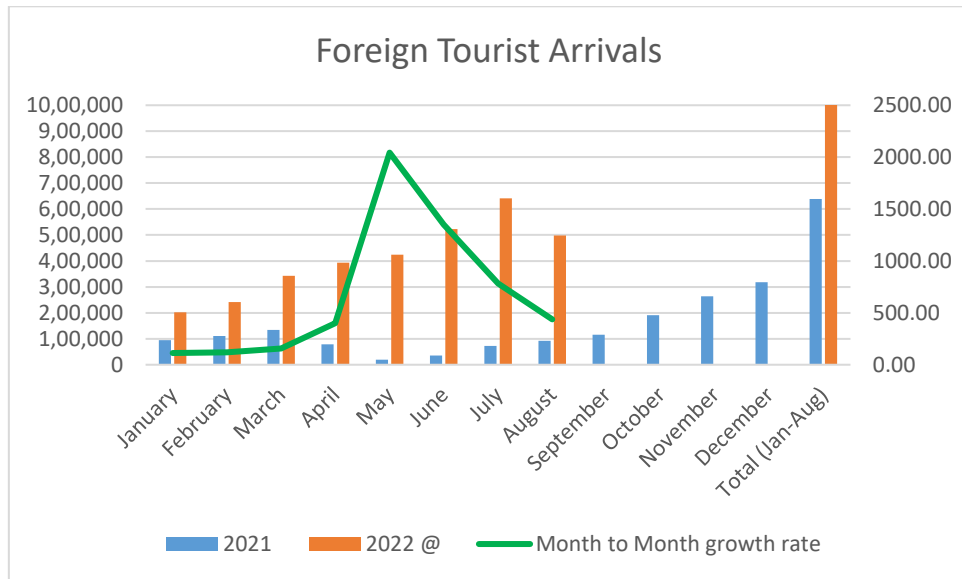
Foreign Tourist Inflow to India August, 2022

Ministry of Tourism compiles monthly Foreign Tourist Arrivals (FTAs) on the basis of information received from Bureau of Immigration (BOI). The following are the important highlights regarding FTAs during the month of August, 2022.

Foreign Tourist Arrivals (FTAs):

- FTAs in August, 2022 were 4,98,243 as compared to 92,728 in August, 2021 and 8,00,837 in August, 2019 registering a growth of 437.3% and -37.8% with respect to 2021 and 2019 respectively.
- FTAs during the period January- August, 2022 were 32,63,219 as compared to 6,38,524 in January-August, 2021 and 69,14,987 in January-August, 2019 registering a growth of 411.1% and -52.8% with respect to 2021 and 2019 respectively.
- The percentage share of Foreign Tourist Arrivals in India during August, 2022 among the top 15 source countries was highest from Bangladesh (24.89%), followed by USA (16.93%), UK (10.74%), Australia (3.77%), Canada (3.44%), Sri Lanka (3.18%), Nepal (2.56%), Malaysia (2.54%), Germany (2.16%), France (2.01%), Oman (1.98%), Singapore (1.73%), UAE (1.45%), Italy (1.19%) and Japan (1.17%).
- The percentage share of Foreign Tourist Arrivals in India during January-August, 2022 among the top 15 source countries was highest from USA (24.52%), followed by Bangladesh (19.57%), UK (10.95%), Australia (4.95%), Canada (4.45%), Sri Lanka (3.29%), Nepal (2.35%), France (1.82%), Germany (1.79%), Singapore (1.72%), Malaysia (1.55%), Maldives (1.37%), Portugal (1.30%), Oman (1.17%) & Russian Federation (0.91%).
- The percentage share of Foreign Tourist Arrivals in India during August 2022 among the top 15 ports was highest at Delhi Airport (28.62%) followed by Mumbai Airport (12.65%), Haridaspur Land Check Post (11.47%), Chennai Airport (10.60%), Bengaluru Airport (6.25%), Cochin Airport (5.37%), Hyderabad Airport (4.45%), Kolkata Airport (3.84%), Ghojadanga Land Check Post (2.13%), Ahmedabad Airport (1.80%), Agartala Land Check Post (1.71%), Tiruchirappalli Airport (1.47%), Trivandrum Airport (1.46%), Chitpur Rail Check Post (1.33%) and Hilli Land Check Post (1.15%).

- The percentage share of Foreign Tourist Arrivals in India during January-August 2022 among the top 15 ports was highest at Delhi Airport (31.20%) followed by Mumbai Airport (13.73%), Chennai Airport (10.44%), Haridaspur Land Check Post (9.23%), Bengaluru Airport (6.63%), Hyderabad Airport (5.49%), Cochin Airport (5.09%), Kolkata Airport (3.98%), Ahmedabad Airport (2.73%), Trivandrum Airport (1.53%), Agartala Land Check Post (1.38%), Ghojadanga Land Check Post (0.97%), Amritsar Airport (0.88%), Tiruchirappalli Airport (0.85%) and Dabolim (Goa) Airport (0.81%).
