### †655. SHRI GAJANAN KIRTIKAR:

Will the Minister of TOURISM be pleased to state:

- (a) whether the Government is taking steps to review the tourism sector in the country;
- (b) if so, the State-wise details thereof; and
- (c) the number of tourist spots identified for integrated development of tourism and the details thereof, State-wise including Maharashtra?

#### ANSWER

#### THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) & (b): Ministry of Tourism organizes National & Regional State Tourism Ministers Conferences from time to time to review the tourism sector and discuss with the States/UTs and stakeholders about schemes, policies and steps being taken for overall tourism development and growth in India. Details of the meetings which have been held recently are:

- a. National Conference of State Tourism Ministers held from 18th to 20th September 2022 in Dharamshala, Himachal Pradesh.
- b. Tourism & Culture Ministers Conference of the North Eastern States held on 13<sup>th</sup> & 14<sup>th</sup> September 2021 at Guwahati, Assam.
- c. Tourism & Culture Ministers Conference of the Southern Region held on 28<sup>th</sup> & 29<sup>th</sup> October 2021 in Bengaluru, Karnataka.

(c): Identification and development of tourist spots is primarily the responsibility of the State Governments/Union Territory Administrations. However, the Ministry of Tourism has provided financial assistance under the 'Swadesh Darshan' and 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' Schemes for the development of tourism related infrastructure in different States/UTs including Maharashtra.

The details of projects sanctioned in the States/UTs including Maharashtra under the above mentioned schemes is given at Annexure.
