Will the Minister of **TOURISM** be pleased to state:

- (a) the details on the tourism projects being/to be undertaken by the Central Government in the State of Telangana;
- (b) the steps being taken to promote eco-tourism in the State;
- (c) the total amount of funds allocated for the development of tourism in the State; and
- (d) the number of UNESCO World Heritage Sites in the State and measures being taken to maintain and preserve the heritage sites?

**STATEMENT** IN REPLY TO PARTS (a) TO (d) OF RAJYA SABHA STARRED QUESTION NO.179 ANSWERED ON 16.03.2023 REGARDING TOURISM IN TELANGANA.

(a) to (c): The Ministry of Tourism has provided financial assistance under the 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' Schemes for the development of tourism related infrastructure in the State of Telangana.

Ministry of Tourism has also provided financial assistance to the State of Telangana for organizing fairs/festivals & tourism related events under Domestic Promotion & Publicity including Hospitality (DPPH) Scheme.

Ministry of Tourism has sanctioned three projects under Swadesh Darshan Scheme for an amount of Rs.268.39 crore, three projects under PRASHAD Scheme for an amount of Rs.140.11 crore and three projects under Assistance to Central Agencies for Tourism Infrastructure Development Scheme for an amount of Rs.65.85 crore in the State of Telangana. In addition to the above, an amount of Rs.245.00 lakh has also been given as financial assistance for organizing Fairs & Festivals and Tourism related events under Domestic Promotion and Publicity including Hospitality (DPPH) Scheme to the State of Telangana. The details of these projects in the State of Telangana are given at Annexure-I.

The Ministry of Tourism has now revamped its Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible destinations following a tourist & destination centric approach. Under SD2.0, Bhongir has been identified for development in the State of Telangana.

Pochampally village in Telangana State has been selected as one of the best Tourism Villages by the United Nations World Tourism Organisation (UNWTO).

Ministry of Tourism has taken several steps for promoting Eco tourism in the country including the State of Telangana:

(i) Ministry of Tourism has identified Eco Circuit as one of the themes for development of tourism circuits under the Swadesh Darshan Scheme.

- (ii) One project namely 'Development of Eco Tourism Circuit in Mahaboobnagar district' for an amount of Rs.91.62 crore was sanctioned in Telangana under the Swadesh Darshan Scheme.
- (iii) Ministry of Tourism has identified Eco-Tourism as a Niche Tourism product for promotion and development in the country including the State of Telangana.
- (iv) To position India as a preferred destination for ecotourism globally, Ministry of Tourism has formulated a National Strategy for Eco-Tourism. Following strategic pillars have been identified for development of ecotourism in the strategy document:
  - a. State Assessment and Ranking
  - b. State Strategy for Eco Tourism
  - c. Information, Education and Communication (IEC), Capacity Building and Certification
  - d. Marketing and Promotion
  - e. Destination and Product Development
  - f. Public Private and Community Partnerships
  - g. Governance and Institutional Framework
- (v) Ministry of Tourism, promotes India in a holistic manner, including eco-tourism sites, in Telangana. Ministry of Tourism releases media campaigns in important and potential markets overseas and within the country under the "Incredible India" brand – line, to promote various tourism destinations and products of the country. The destinations, including eco-tourism sites, in Telangana are promoted through the official website of the Ministry - www.incredibleindia.org as well as through the Social Media handles of the Ministry.
- (d): As per Archaeological Survey of India (ASI), presently, there is only one property namely Kakatiya Rudreshwara (Ramappa) Temple, Telangana inscribed on World Heritage List in the year 2021. This temple is protected and maintained by the Archaeological Survey of India and is in good state of preservation.

Furthermore, a list of 40 World Heritage Properties of India is at Annexure-II.
