#### **ONGOING PROJECTS IN KERALA**

#### **4290.ADV. DEAN KURIAKOSE:**

Will the Minister of TOURISM be pleased to state:

- (a) whether the Government has details of all central programs and projects in the tourism sector in the State of Kerala;
- (b) if so, the district-wise details thereof;
- (c) whether the Government has details of ongoing projects under in the tourism sector in the State of Kerala;
- (d) if so, the details thereof, including the present status of the projects;
- (e) whether the Government has details of all central programs and projects in the tourism sector in the Idukki Parliamentary Constituency;
- (f) if so, the details thereof, including the present status of these programs and projects; and
- (g) the details of major tourist spots in the State of Kerala, along with the annual footfall?

#### **ANSWER**

#### THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (g): Identification and development of tourist places/spots is primarily the responsibility of the State Governments/Union Territory Administrations. However, the Ministry of Tourism has provided financial assistance under the 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' Schemes for the development of tourism related infrastructure in the State of Kerala.

Ministry of Tourism has also provided financial assistance to the State of Kerala for organizing fairs/festivals & tourism related events under Domestic Promotion & Publicity including Hospitality (DPPH) Scheme.

The details of the projects sanctioned along with their status in the State of Kerala under the above mentioned schemes is given at Annexure.

A project 'Development of Pathanamthitta-Gavi-Vagamon- Thekkady has been sanctioned in the year 2015-16 under the Swadesh Darshan Scheme for an amount Rs.64.08 crore in Kerala which includes interventions for an amount of Rs.52.11 crore in the district of Idukki. The project is physically completed.

Proposals are received from State Governments/Union Territory Administrations from time to time for seeking financial assistance under the above schemes of the Ministry of Tourism. These proposals are examined in context of the scheme guidelines and financial assistance is extended for projects subject to fulfilment of the stipulated provisions and availability of funds.

Ministry of Tourism does not maintain destination wise data on tourist visits. However, Domestic & Foreign Tourist Visits in Kerala during last 3 years is as follows:
