STATEMENT IN REPLY TO PARTS (a) TO (c) OF LOK SABHA STARRED QUESTION NO.*454 ANSWERED ON 03.04.2023 REGARDING DEVELOPMENT OF SEA BEACHES

(a) to (c): Identification and development of tourist places is primarily the responsibility of the concerned State Government/Union Territory (UT) Administration however the Ministry of Tourism under its 'Swadesh Darshan' scheme (SDS) provides financial assistance to the State Governments/Union Territory Administrations/Central Agencies etc. for development of tourism infrastructure. Since the inception of this scheme in the year 2014-15, the Ministry of Tourism has sanctioned 10 projects under Coastal Circuit theme including development works at sea beaches in the country. Under SDS, funds are released in instalments, as per the release procedure stipulated in the scheme guidelines and component wise amount is not released. The details of the projects sanctioned under Swadesh Darshan scheme in coastal circuit is as under: -
