### PRASHAD SCHEME IN UTTAR PRADESH

### 3980# SHRI MITHLESH KUMAR:

Will the Minister of **TOURISM** be pleased to state:

- (a) the projects sanctioned under the Pilgrimage Rejuvenation And Spiritual Heritage Augmentation Drive (PRASHAD) Scheme till date, the details thereof, State-wise, including Uttar Pradesh;
- (b) whether Government has any other proposal to implement under the said Scheme in Uttar Pradesh and if so, the details thereof;
- (c) the details of funds sanctioned under PRASHAD scheme till date, State-wise;
- (d) whether the proposals submitted by the Government of Uttar Pradesh are still pending; and
- (e) the infrastructure and basic amenities developed for tourists under the above Scheme across the country, the details thereof, State/UT-wise, including Uttar Pradesh?

### ANSWER

#### THE MINISTER OF TOURISM

#### (SHRI G. KISHAN REDDY)

(a) to (e): Development of tourism is primarily the responsibility of the concerned State Government (SG)/Union Territory Administration (UTA), however, the Ministry of Tourism provides Financial Assistance to SG/UTA for development of tourism infrastructure in the country including in the State of Uttar Pradesh under Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive' (PRASHAD) Scheme. The PRASHAD Scheme is aimed at integrated development of the religious and heritage destinations which is done by development of pilgrimage amenities centres, facilitation centres, toilet blocks, last-mile connectivity, digital interventions, parking, and other related infrastructure to address the crucial infrastructure gaps of the destination and improve the overall experience of tourists/pilgrims. Submission of proposals and sanctioning of projects under the scheme is a continuous process which is done in consultation with the respective SG/UTA and is subject to availability of funds, receipt of suitable detailed project reports, adherence to scheme guidelines, performance of ongoing projects and utilization of funds released earlier etc. Based on the above, Ministry of Tourism has approved 45 projects under the Scheme in the country including 6 in the State of Uttar Pradesh, State/UT-wise details of which including fund sanctioned is annexed.
