FUNDS SPENT UNDER RAMAYANA CIRCUIT AND SDS

†5224. SHRI GOPAL JEE THAKUR:

Will the Minister of TOURISM be pleased to state:

- (a) the site-wise amount of funds spent by the Government in Mithila region under the Ramayana Circuit and Swadesh Darshan Schemes;
- (b) whether the Government proposes to develop Shyama Mai temple complex, a famous pilgrimage site at Darbhanga in Mithila region under the Swadesh Darshan and PRASAD Schemes; and
- (c) if so, the details thereof?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (c): The Ministry of Tourism under its Swadesh Darshan scheme has sanctioned 5 projects in Bihar covering Tirthankara, Spiritual, Buddhist & Rural circuit themes and 1 project in Jharkhand covering Eco Circuit theme. However, no project under Ramayana Circuit theme is sanctioned in Bihar and Jharkhand including Mithila Region. In addition, the Ministry of Tourism has also sanctioned projects under its 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' scheme in the State of Bihar and Jharkhand. The details of the projects sanctioned under 'Swadesh Darshan' and 'PRASHAD' schemes in Bihar and Jharkhand is annexed.

The Ministry of Tourism has now revamped Swadesh Darshan scheme as Swadesh Darshan 2.0 (SD2.0) for development of sustainable and responsible tourist destinations in the country and has identified 'Nalanda' and 'Gaya' in Bihar as destinations for development under SD2.0. As of now, there is no proposal for consideration to develop 'Shyama Mai temple complex' in Dharbhaga under 'Swadesh Darshan' and 'PRASHAD' schemes.
