## **NOTIFICATION**

New Delhi, dated ..... May, 2023

G.S.R ----- in exercise of the powers conferred by the proviso to article 309 of the constitution and in super-session of the Department of Tourism Headquarters establishment (Lower Division Clerk) Recruitment Rules, 1990, excepts as respects things done or omitted to be done before such super-session, the President hereby makes the following rules regulating the method of recruitment to the post of Lower Division Clerk in the Ministry of Tourism (Headquarters Establishment) namely: -

1. Short title and Commencement:

(i) These rules may be called the Ministry of Tourism, Headquarters Establishment, Lower Division Clerk (LDC) Recruitment Rules, 2023

(ii) They shall come into force on the date of their publication in the official Gazette.

2. Number of post, classification and scale of pay matrix. - the number of the said post, its classification and scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

3. Method of recruitment, age-limit and qualification, etc.- The method of recruitment age limit, qualifications and other matters relating to the said post shall be as specified in Columns 5 to 13 of the said Schedule.

4. Disqualification – No person -

(a) Who has entered into or contracted a marriage with a person having a spouse living, or

(b) who having a spouse living, has entered in contracted a marriage with any person Shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax- Where the Central Government is of the opinion that it is necessary or expedient so to it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service commission relax any of the provisions of these rules respect to any class or category of persons.

6. Savings. - Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Schedule Castes. Schedule Tribes, Ex.

Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
