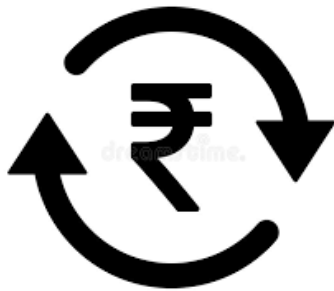

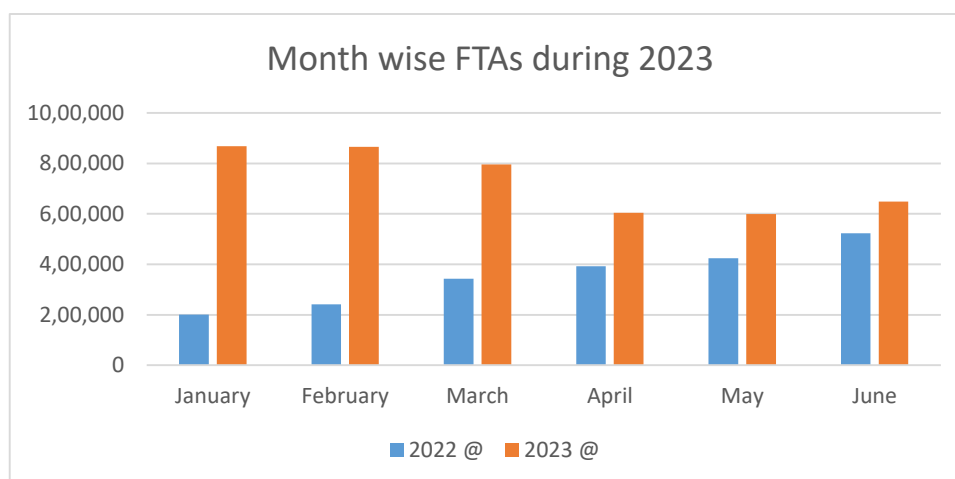

Foreign Tourist Arrivals (FTAs)

- FTAs in June, 2023 were 6,48,008 as compared to 5,22,737 in June, 2022 and 7,26,446 in June, 2019 registering a growth of 24.0% and -10.8% with respect to 2022 and 2019 respectively.
- FTAs during the period January- June, 2023 were 43,80,239 as compared to 21,24,118 in January-June 2022 and 52,96,025 in January-June, 2019 registering a growth of 106.2% and -17.3% with respect to 2022 and 2019 respectively.

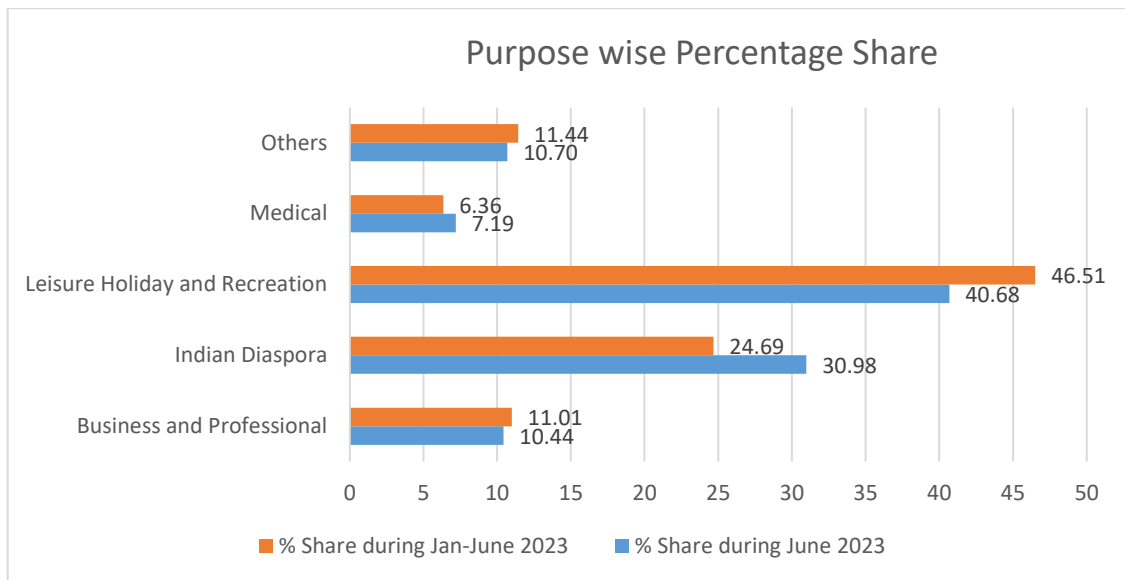

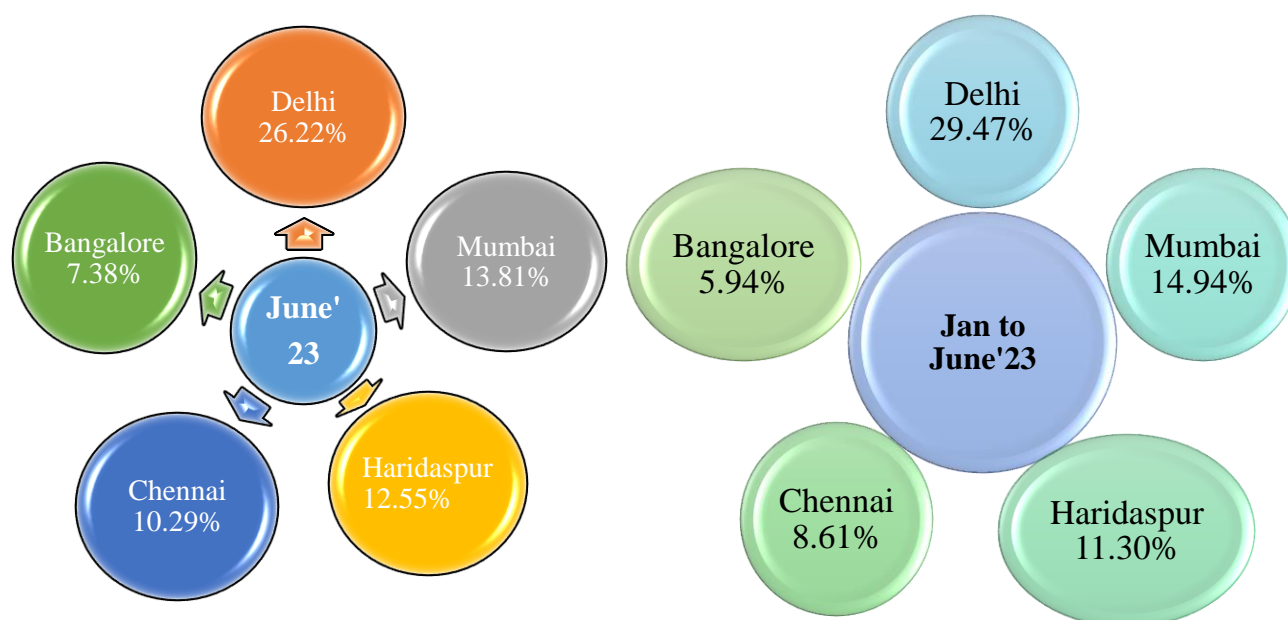

The percentage Share of Foreign Tourist Arrivals in India during June'23 and Jan-June 23 among the top 5 ports



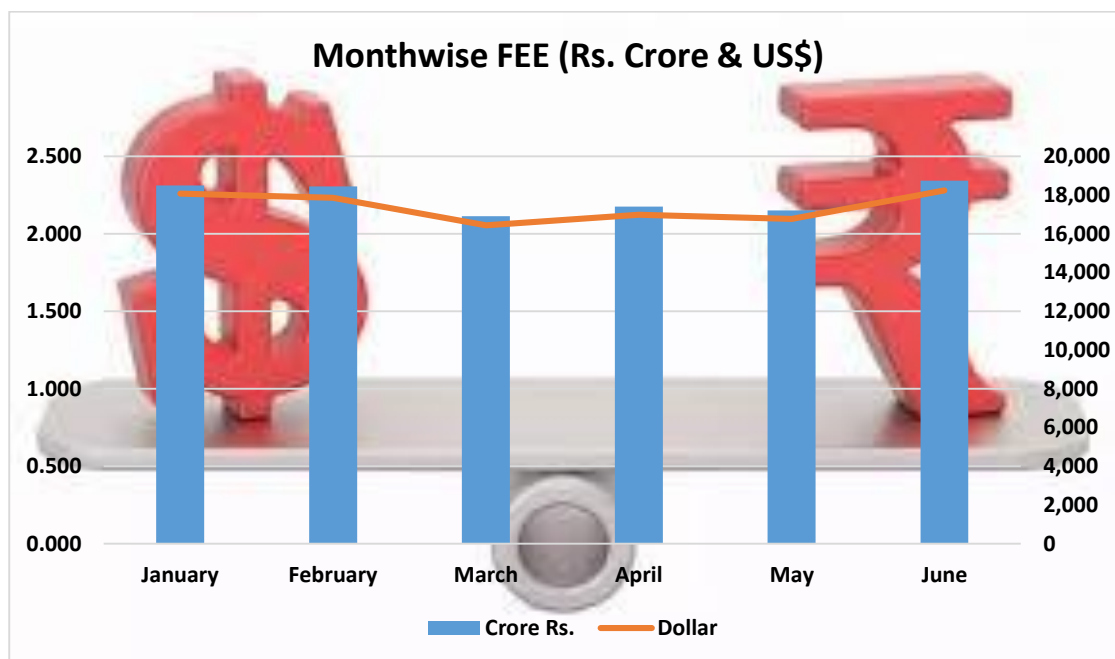
Foreign Exchange Earnings

- FEEs during the month of June 2023 were Rs. 18,737 crore as compared to Rs. 12,766 crore in June 2022 and Rs. 16,592 Crore in June, 2019 registering a growth of 46.78% and 12.93% with respect to 2022 and 2019 respectively.
- FEEs in US\$ terms during the month of June 2023 were US\$ 2.279 billion as compared to FEEs of US\$ 1.635 billion during the month of June 2022 and US\$ 2.386 billion in June, 2019 registering a growth of 39.382% and -4.48% with respect to 2022 and 2019 respectively.



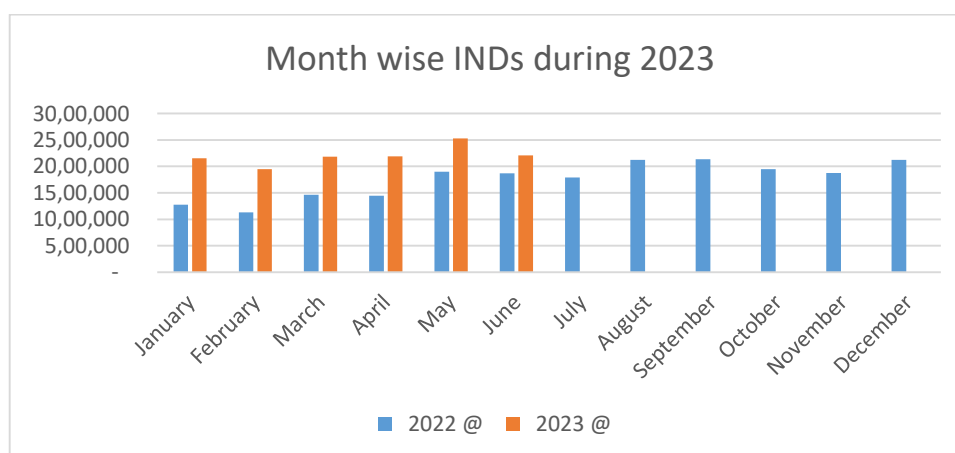
- FEEs during the period January- June 2023 were Rs. 1,07,178 crore as compared to Rs. 46,712 crore in January- June 2022 and Rs. 1,01,774 Crore in January-June, 2019 registering a growth of 129.44% and 5.31% with respect to 2022 and 2019 respectively.

- FEE during the period January- June 2023 were US \$ 13.041 billion as compared to US \$ 6.090 billion in January- June 2022 and US \$ 14.534 billion January- June 2019 registering a growth of 114.12% and -10.27% with respect to 2022 and 2019 respectively.



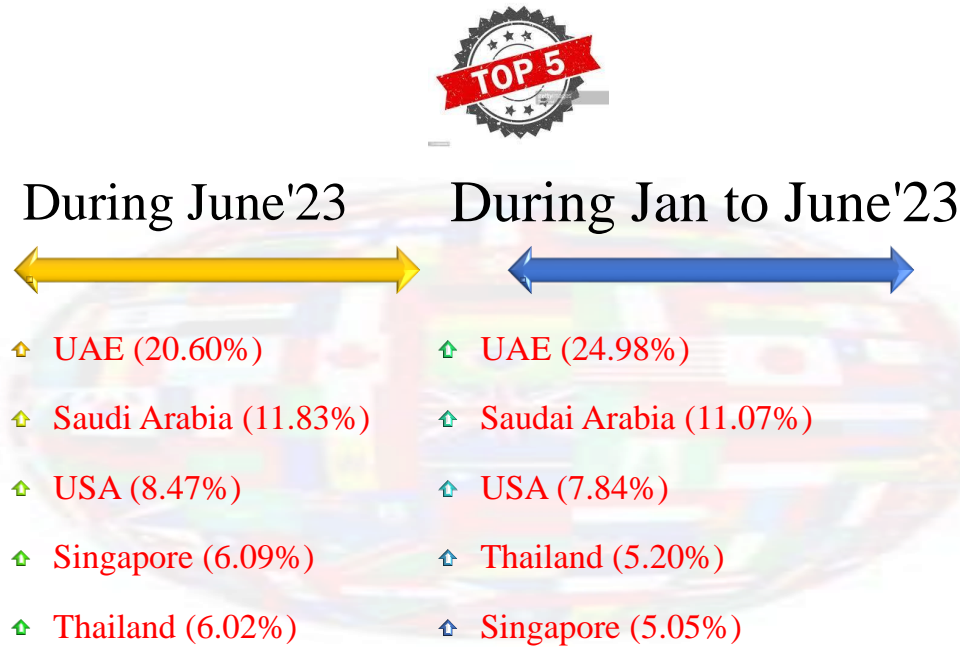
Indian Nationals Departures

- INDs in June 2023 were 22,08,909 as compared to 18,68,979 in June 2022 and 21,98,582 in June 2019 registering a growth of 18.2% and 0.5% with respect to 2022 and 2019 respectively.
- INDs during the period January- June, 2023 were 1,32,08,837 as compared to 90,92,902 in January- June, 2022 and 1,33,80,079 in January-June 2019 registering a growth of 45.3% and -1.3% with respect to 2022 and 2019 respectively.

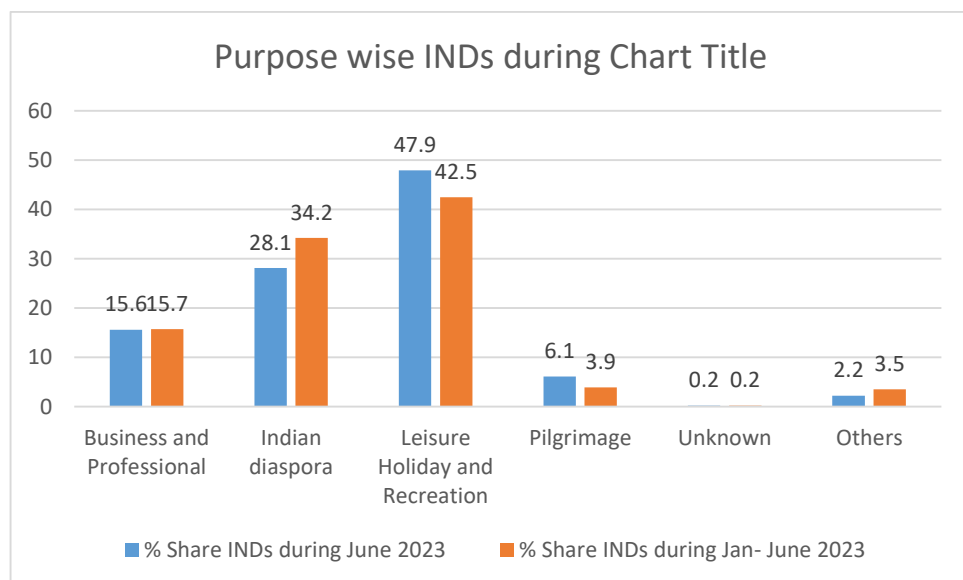

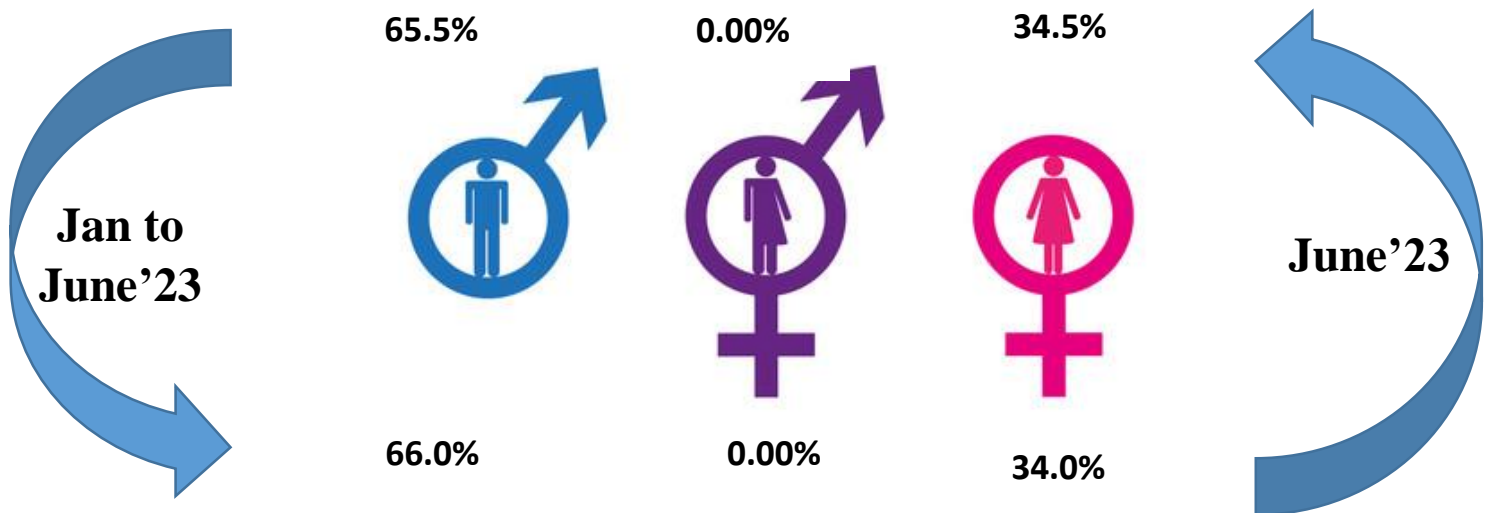
The percentage share of Indian National Departures during June and during Jan to June among the top 5 source countries



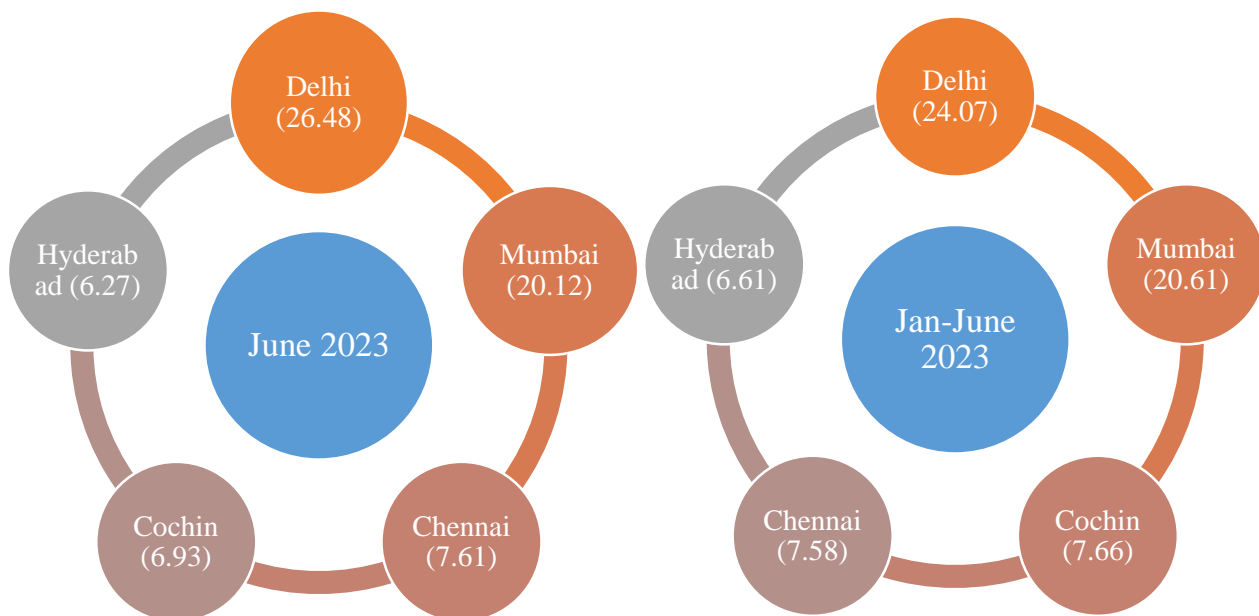
The Purpose wise percentage share of Indian National Departures during June'23 and during Jan to June'23



- Gender wise % distribution

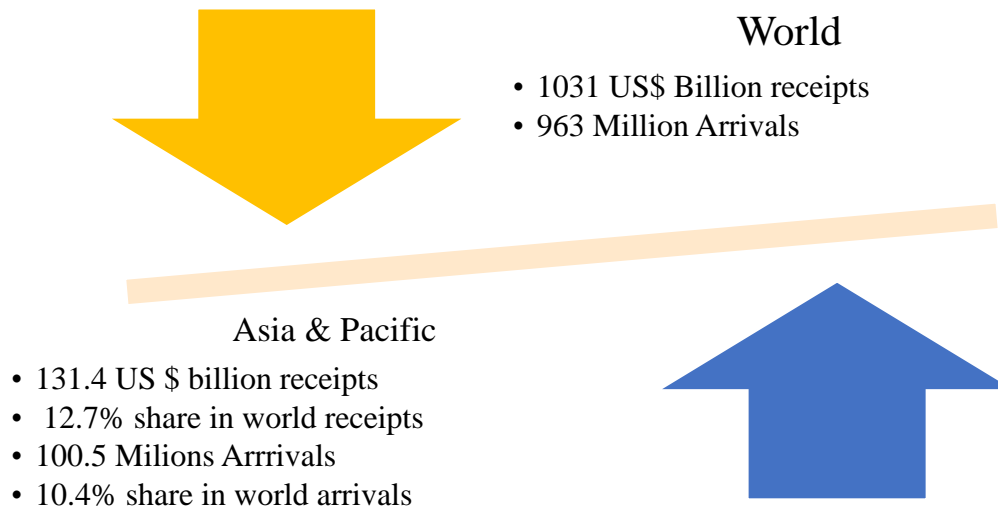


The percentage share of INDs during June'23 and Jan-June'23 among the top 5 ports
