**ANSWER**

(SHRI G. KISHAN REDDY)

(a) to (e): The Ministry of Tourism launched its ‘Swadesh Darshan Scheme’ (SDS) in 2014-15 with the objective of integrated development of Theme-Based Tourist Circuits in the country and sanctioned 76 projects under various identified themes in the country including Tamil Nadu; the details of which is annexed.

The Ministry of Tourism has revamped the Swadesh Darshan scheme as Swadesh Darshan 2.0 with the objective to develop sustainable and responsible tourism destinations and has identified ‘Mamallapuram’ and ‘The Nilgiris’ as destinations for development in the State of Tamil Nadu.
