(a) to (c): Ministry of Tourism under its ongoing schemes/programmes promotes various tourism destinations and products of the country in a holistic manner. In addition with the objective to develop tourism infrastructure in the country, the Ministry of Tourism provides financial assistance to State Governments/Union Territory Administrations/Central Agencies under its 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' Schemes. Ministry of Tourism also provides financial assistance to State Governments/Union Territory Administrations for organizing fairs/festivals & tourism related events under Domestic Promotion & Publicity including Hospitality (DPPH) Scheme.

The financial assistance provided for implantations of various tourism projects provide direct and indirect employment opportunities in various tourism related sectors.

The details of projects along with their status sanctioned in the State of Bihar in last five years under the above-mentioned schemes is given at ANNEXURE.
