Will the Minister of TOURISM be pleased to state:

- (a) whether the Government has received any proposal to provide funds for the development of tourist destinations in Nanded, Maharashtra;
- (b) if so, the details thereof;
- (c) whether it is also a fact that the Maharashtra State Government has sent a list to provide funds for the development of tourist places of Nanded; and
- (d) if so, the action taken in this regard and the time by which said funds are likely to be made available?

ANSWER

THE MINISTER OF TOURISM

(a) to (d): The Ministry of Tourism under the Schemes of 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' provides financial assistance to State Governments/Union Territory Administrations /Central Agencies for the development of tourism related infrastructure and facilities at various tourism destinations in the country including Maharashtra. The details of projects sanctioned and funds allocated under the above mentioned Schemes in the State of Maharashtra including Nanded is Annexed. The Ministry of Tourism receives proposals for financial support under the above mentioned schemes as part of an ongoing process, which are examined in line with the scheme guidelines and other instructions issued by the Ministry of Tourism from time to time. Further, the Ministry of Tourism has revamped the Swadesh Darshan scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourism destinations and has identified 'Sindhudurg' in Maharashtra for development under this scheme.
