- (a) whether there is any scheme of Government on wildlife tourism, if so, the State-wise details thereof, including Rajasthan;
- (b) the details of the initiatives taken by Government to expand wildlife and forest tourism in National Parks and Wildlife Sanctuaries in the State of Rajasthan; and
- (c) the efforts made by Government to promote wildlife and forest tourism during the last two years?

ANSWER

(a) to (c): The Ministry of Tourism under its scheme of Swadesh Darshan identified Wildlife Circuit and Eco Circuit as among 15 thematic circuits for development. The above circuits cover National Parks, Wildlife Sanctuaries and Reserves in the country. The details of projects sanctioned under the Wildlife and Eco Circuits of Swadesh Darshan scheme is various States/UTs is at Annexure. No project has been sanctioned in the State of Rajasthan under the above two circuits of the scheme.

Apart from above, Ministry of Environment, Forest & Climate Change has informed that they have issued "Guidelines for sustainable ecotourism in forest and wildlife areas – 2021".

In addition to above, as part of its on-going activities, Ministry of Tourism, releases global print, electronic and online media campaigns in important and potential markets overseas, under the 'Incredible India' brand-line, to promote various tourism destinations and products of the country. Digital promotions are also regularly undertaken through the Social Media accounts of the Ministry on different themes including the theme of Wildlife Tourism.
