**DEVELOPMENT OF SPECIAL FESTIVAL TOURISM CIRCUIT**

**311. SHRI T.N. PRATHAPAN:**

**Will the Minister of TOURISM be pleased to state:**

- (a) whether the Government proposes to develop a special festival tourism circuit around Thrissur with special reference to the Thrissur Pooram Festival and if so, the details thereof;**
- (b) whether the Government has released adequate funds for the development of Guruvayoor temple and the Temple town under PRASHAD scheme and if so, the details thereof;**
- (c) whether the Government is aware of the tourism potential of beaches such as Snehatheeram Beach, Thalikkulam and Chavakkad Beach in Thrissur Constituency;**
- (d) if so, the details of the initiatives taken by the Government for the same; and**
- (e) the details of funds released and utilized for promotion of tourism projects supported by the Government in Thrissur?**

**ANSWER**

**THE MINISTER OF TOURISM**

**(SHRI G. KISHAN REDDY)**

**(a): No intervention has been sanctioned in Thrissur to develop a special festival tourism circuit. However, under the Swadesh Darshan Scheme, the Ministry of Tourism has sanctioned financial assistance to the State of Kerala for Development of Eco Circuit, Spiritual Circuit and Rural Circuit during 2015-16 to 2018-19 the details of which are at annexure.**

**(b): The Ministry of Tourism, under the PRASHAD Scheme, sanctioned a project 'Development of Guruvayur Temple, Thrissur' for Rs.45.19 crore in Kerala. The project is now completed and the facilities are open to the public.**

**(c) & (d): Ministry of Tourism promotes India as a holistic destination to promote various tourism destinations including beaches, products, fairs & festivals etc. of the Country.**

**The Ministry also provides Central Financial Assistance to State Governments/UT Administrations for organising fairs, festivals and tourism related events under Domestic Promotion & Publicity including Hospitality Scheme (DPPH) based on proposals received from the States/Union Territories, subject to adherence to scheme guidelines and availability of funds.**

**(e): The details of funds released under the Events Support scheme of the Ministry of Tourism for Thrissur is as under:**
