**DEVELOPMENT OF ALL WEATHER TOURISM IN THE COUNTRY**

785. SHRI ZALA KESRIDEVSINHJI:

Will the Minister of **TOURISM** be pleased to state:

- (a) the details of the Niche Tourism products identified by the Ministry to boost all weather year-round tourism in the country;
- (b) the names of such destinations identified till date for the same; and
- (c) the likely enhanced revenue and employment generations from this innovative move of Government?

**ANSWER**

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a): In order to position India as a preferred destination for various Niche Tourism products, Ministry of Tourism has formulated the following National Strategies:-

- i. National Strategy for Sustainable Tourism
- ii. National Strategy and Roadmap for development of Rural Tourism in India – an initiative towards Aatmanirbhar Bharat
- iii. National Strategy for Adventure Tourism
- iv. National Strategy for MICE Industry
- v. National Strategy for Ecotourism
- vi. National Strategy and Roadmap for Medical & Wellness Tourism

In addition to the above Ministry has prepared the following draft strategies:-

- i. National Strategy for Cruise Tourism
- ii. National Strategy for Film Tourism

(b) & (c): Under its scheme of Swadesh Darshan Ministry provides financial assistance to State Governments/UT Administrations for development of tourism infrastructure in the country. Details of projects sanctioned by the Ministry under its Swadesh Darshan Scheme is at **Annexure-I**.

The Ministry of Tourism has now revamped its Swadesh Darshan scheme in the form of Swadesh Darshan 2.0 with the mission to create a robust framework for integrated development of tourism destinations in partnership with the States/UTs and local governments for promoting sustainable and responsible tourism in the country. In consultation with the State Governments/UT Administrations 57 destinations across 32 States/UTs have been identified for development under Swadesh Darshan 2.0 scheme. The list of these destinations is at **Annexure-II**.

A third party assessment of Swadesh Darshan scheme was undertaken by National Productivity Council (NPC) in July, 2019; which states that 'Swadesh Darshan Scheme' has been able to give a fillip to livelihood opportunities and create employment for the local communities in construction phase.
