#### FUNDS FOR TOURISM INFRASTRUCTURE

788 SHRI M. SHANMUGAM: SHRI VAIKO:

Will the Minister of **TOURISM** be pleased to state:

- (a) the funds allotted under various schemes of the Ministry for the State of Tamil Nadu, particularly to districts namely Tiruchy, Thanjavur, Tiruvarur, Mayiladuthurai, Tenkasi, Virudhnagar, Tirunelveli and Kanyakumari which have rich and abundant tourist places and eco tourism;
- (b) the details of projects undertaken in the State for fostering sustainable and responsible centric approaches to improve tourism infrastructure; and
- (c) whether more funds will be allotted under various schemes for the State, in view of lot of potential for the tourism development, details thereof?

#### **ANSWER**

#### THE MINISTER OF TOURISM

(a) to (c): The Ministry of Tourism under the schemes of 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' provides financial assistance to State Governments/Union Territory Administrations/Central Agencies for the development of tourism-related infrastructure and facilities at various tourism destinations in the country.

The details of projects sanctioned under the above-mentioned schemes in the State of Tamil Nadu is given at **Annexure**.

The Ministry of Tourism has now revamped the Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD 2.0) with the objective to develop sustainable and responsible tourism destinations, following a destination & tourism-centric approach. Under SD 2.0, 'Mamallapuram' & 'The Nilgiris' destinations have been identified for development in the State of Tamil Nadu.

Proposals are received from States/UTs from time to time for seeking financial assistance under the various schemes of the Ministry of Tourism. These proposals are examined in context of the scheme guidelines and financial assistance is extended for projects subject to fulfilment of the stipulated provisions and availability of funds.
