Will the Minister of TOURISM be pleased to state:

- (a) the details of the Tourism Circuits selected by the Government in the State of Andhra Pradesh, with particular reference to the Kadapa District;
- (b) whether the Government has decided to select these projects under Theme-based tourist circuits, if so, the number of tourist places identified for development under the Swadesh Darshan Scheme, in the State of Andhra Pradesh, especially in Kadapa District; and
- (c) the details of the amount of financial assistance provided for each integrated tourist circuit, the funds released so far and the projects taken up and the status of those projects?

STATEMENT IN REPLY TO PARTS (a) TO (c) OF LOK SABHA STARRED QUESTION NO.\*187 ANSWERED ON 05.08.2024 REGARDING THEME BASED TOURIST CIRCUIT RAISED BY SHRI Y S AVINASH REDDY.

(a) to (c): The Ministry of Tourism through its central sector schemes of 'Swadesh Darshan (SD)' and 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive' (PRASHAD) complements the efforts of tourism infrastructure development by extending financial assistance to the State Governments/UT Administrations including the State of Andhra Pradesh. The Ministry of Tourism has sanctioned 3 projects each under its Swadesh Darshan and PRASHAD schemes in the State of Andhra Pradesh. Further, under its scheme of 'Assistance to Central Agencies', the Ministry of Tourism has sanctioned 2 projects in Andhra Pradesh. The details of the projects sanctioned under SD, PRASHAD and Assistance to Central Agencies schemes are annexed.

The Ministry of Tourism has recently revamped the Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourism destinations, following a destination & tourism-centric approach. In consultation with the States/UTs and in line with the scheme guidelines, the Ministry has accordingly identified 57 destinations in the country for development under SD 2.0 including 'Gandikota' and 'Arakku-Lambassingi' in Andhra Pradesh and has sanctioned following projects/interventions in the financial year 2023-24 at Arakku-Lambasingi:

The Ministry of Tourism has also issued guidelines for 'Challenge Based Destination Development' (CBDD), a sub-scheme under Swadesh Darshan 2.0, under which the Ministry of Tourism has identified 42 destinations for development in the country including 'Nagarjuna Sagar' and 'Ahobilam Temple' in Andhra Pradesh. The Ministry has further identified 'Annavaram, Kakinada District' and 'Vedagiri Lakshmi Narasimhaswamy Temple, Nellore District' in Andhra Pradesh for development under PRASHAD scheme.
