Clause 2.5 Pt (iv)	Additionally, agencies selected as the NPMU for the Ministry of Tourism will not be eligible to work on the projects for State Governments or Union Territories (UT's) funded by the various schemes of the Ministry of Tourism. This is to ensure no conflict of Interest arise. Agencies are therefore advised to avoid any situation that could lead to potential conflict of Interest.	The agency selected as the NPMU has to ensure that they are not engaged into project preparation work at State Governments/ UT Administrations level, which will be submitted to the Ministry of Tourism for its consideration under the schemes for which the agency is working as NPMU.
