



# 1.Foreign Tourist Arrivals (FTAs)

- **1.1** FTAs in September, 2024 were 6,69,573 as compared to 6,66,946 in September, 2023 and 7,51,513 in September, 2019 registering a growth of 0.4% and -10.9% with respect to 2023 and 2019 respectively.
- **1.2** FTAs during the period January-September, 2024 were 68,60,334 as compared to 66,38,150 in January-September 2023 and 76,66,500 in January-September, 2019 registering a growth of 3.3% and -10.5% with respect to 2023 and 2019 respectively.






1.3 Percentage Share of Foreign Tourist Arrivals in India during September 2024 and during January to September 2024 among the top 5 source countries





# 1.4 Purpose wise percentage share of Foreign Tourist Arrivals in India during September 2024 and during January to September 2024





# 1.6 Percentage Share of Foreign Tourist Arrivals in India during September 2024 and January-September 2024 among the top 5 ports






# 2. Foreign Exchange Earnings

- **2.1** FEEs during the month of September 2024 were Rs.20,462 crores as compared to Rs.18,534 crores in September 2023 and Rs.17,064 Crore in September, 2019 registering a growth of 10.40% and 19.91% with respect to 2023 and 2019 respectively.
- **2.2** FEEs in US\$ terms during the month of September 2024 were US\$ 2.442 billion as compared to FEEs of US\$ 2.232 billion during the month of September 2023 and US\$ 2.423 billion in September, 2019 registering a growth of 9.41% and 0.78% with respect to 2023 and 2019 respectively.




- **2.3** FEEs during the period January-September 2024 were Rs.1,91,749 crores as compared to Rs.1,66,660 crores in January-September 2023 and Rs.1,55,599 Crore in January-September, 2019 registering a growth of 15.05% and 23.23% with respect to 2023 and 2019 respectively.
- **2.4** FEE during the period January- September 2024 were US\$ 22.997 billion as compared to US\$ 20.239 billion in January- September 2023 and US\$ 22.176 billion January- September 2019 registering a growth of 13.63% and 3.70% with respect to 2023 and 2019 respectively.





- 3.1 INDs in September 2024 were 26,49,758 as compared to 25,21,229 in September 2023 and 23,54,445 in September 2019 registering a growth of 5.10% and 12.54% with respect to 2023 and 2019 respectively.
- **3.2** INDs during the period January- September, 2024 were 2,27,12,497 as compared to 2,08,58,101 in January- September, 2023 and 2,02,66,662 in January-September 2019 registering a growth of 8.89% and 12.07% with respect to 2023 and 2019 respectively.




3.3 Percentage Share of Indian Nationals' Departures during September 2024 and during January to September 2024 among the top 5 source countries




# 3.4 Purpose wise percentage share of Indian Nationals' Departures during September 2024 and during January to September 2024




### 3.5 Gender wise distribution




# 3.6 Percentage Share of INDs during September 2024 and January-September 2024 among the top 5 ports
