Preface

The India Tourism Data Compendium 2024, now in its 65th edition, has been compiled by the Research & Analytics Division of the Ministry of Tourism. This publication presents key statistical highlights, continuing the legacy of previous editions known as India Tourism Statistics. This year, the compendium has been further enriched with new chapters that provide global and regional bloc-wise comparisons, offering a broader context for India's standing among major tourist destinations and markets.

This compendium delivers critical insights into key tourism indicators, including inbound and outbound tourism trends, foreign exchange earnings, and domestic and international tourist visits. It serves as an invaluable resource for policymakers, industry leaders, researchers, and stakeholders, reinforcing the Ministry of Tourism's commitment to the advancement of India's tourism sector.

The compilation of this report has been made possible through the invaluable contributions of key organizations, including the Bureau of Immigration (BOI), State and Union Territory Administrations, the Archaeological Survey of India (ASI), and the United Nations World Tourism Organization (UNWTO). Their support has ensured the authenticity, accuracy, and credibility of the data presented in this edition.

India's tourism sector has shown remarkable recovery in 2023, with a significant surge in Foreign Tourist Arrivals (FTAs) and Domestic Tourist Visits (DTVs), signaling a positive trajectory for the future.

Global Scenario

Global tourism has shown a notable recovery, with international arrivals reaching 1,300 million in 2023, a 33.3% increase from 2022 (UNWTO estimates). This resurgence highlights tourism's role in economic growth, job creation, and cultural exchange, especially in emerging markets. The global International Tourist Receipts reached USD 1,507 billion, reflecting a 33.8% growth, indicating a strong recovery and expansion in the tourism sector. India has strengthened its position in global tourism, accounting for 1.45% of total international arrivals and 2.1% of worldwide tourism receipts. India ranks 39th in the World Economic Forum's Travel and Tourism Development Index (TTDI) 2024. It also excels in Price Competitiveness (18th), Air Transport Infrastructure (26th), and Ground & Port Infrastructure (25th). The top 10 International Tourist Arrival (ITA) source countries are France, Spain, the US, Italy, Turkey, Mexico, the UK, Germany, Greece, and Austria.

India's Tourism Performance

International Tourist Arrivals (ITAs) have reached 18.89 million, surpassing the previous peak of 17.91 million in 2019 and exceeding pre-pandemic levels, registering a growth of 5.47% over 2019. Foreign Tourist Arrivals (FTAs) in India have grown significantly over the decades, reaching 10.93 million in 2019 before the pandemic caused a decline. With recovery underway, 9.52 million FTAs were recorded in 2023, achieving 87.09% of prepandemic levels with a 47.89% increase from 2022 (6.44 million). Non-Resident Indian (NRI) arrivals also surged to 9.38 million in 2023, marking an 18.9% increase from 2022 and exceeding pre-pandemic levels by 34.38%. South Asia contributed the largest share of FTAs (29.02%), followed by North America (21.82%) and Western Europe (20.40%). The top 10 source markets were Bangladesh, the US, the UK, Australia, Canada, Sri Lanka, Malaysia, Germany, Nepal, and France, accounting for 70.06% of total FTAs. The peak travel month was December (1.10 million arrivals, 11.5% share), indicating strong winter holiday demand.

Air travel dominated, accounting for 79.4% of FTAs, with 57.2% landing in Delhi and Mumbai. In 2023, Foreign Exchange Earnings (FEE) from tourism were US\$ 28.077 billion, a 31.5% growth from US\$ 21.360 billion in 2022. The average spending by a foreign tourist in India (excluding transport) was ₹2.90 lakh, highlighting the economic impact of inbound tourism

Domestic tourism also saw robust growth, with 2,509.63 million visits in 2023, a 44.98% increase from 2022 (1,731.01 million). Foreign tourist visits reached 19.25 million, up 124.11% from 8.59 million in 2022. Uttar Pradesh (478.53 million) and Tamil Nadu (286.01 million) led in domestic visits, while Maharashtra (3.39 million) and Gujarat (2.81 million) had the highest foreign tourist numbers. The Taj Mahal remained the top visited ASI Ticketed monument, attracting 6.10 million domestic and 0.68 million foreign tourists.

India's Growth Potential

India's tourism sector holds immense potential, driven by its rich cultural heritage, diverse landscapes, and expanding infrastructure. The country is home to 43 UNESCO World Heritage Sites, attracting millions of tourists. Adventure tourism is rapidly growing, with the Himalayas, Western Ghats, and coastal regions offering trekking, river rafting, paragliding, and scuba diving experiences. Wellness and medical tourism are also key contributors, with India being a global hub for Ayurveda, Yoga, and affordable healthcare, drawing 6.9% of foreign visitors for medical purposes in 2023. The Meetings, Incentives, Conferences, and Exhibitions (MICE) sector is emerging as a major segment, drawing 10.3% of foreign visitors for Business Purpose in 2023; supported by world-class convention centers such as Yashobhoomi (IICC Delhi) and Bharat Mandapam, enhancing India's position as a preferred business tourism destination.

Tourism contributed 5% to India's GDP in 2023. Several government initiatives are accelerating tourism development, including Swadesh Darshan 2.0, which focuses on sustainable, destination-centric tourism, and the PRASHAD scheme, aimed at enhancing infrastructure around pilgrimage and spiritual sites. Improved connectivity through the UDAN scheme and the expansion of airports, bringing the total to 157, and the addition of 517 new air routes have further boosted accessibility across the country. Additionally, the e-Visa facility, now available to travelers from 167 countries, has made India a more convenient and attractive destination for international tourists.

India's global recognition in tourism is strengthening, with the country ranking 39th in the Travel & Tourism Development Index (TTDI) 2024 by the World Economic Forum and being one of only three countries in the top 10 across all three pillars of T&T Resources dimension. It holds strong positions globally for Natural Resources (6th), Cultural Resources (9th), and Non-Leisure Resources (9th), along with high price competitiveness (18th). With International Tourist Arrivals (ITAs) surpasses pre-pandemic levels and expected to reach 20 million by 2025, domestic tourism remains a key driver, with over 3 billion visits anticipated. Segments like MICE and luxury tourism are also expected to expand, attracting high-spending tourists to metropolitan and heritage sites and cities. With continued investment in tourism infrastructure, policy support, and a focus on sustainable and experience-driven travel, India is on the road to becoming one of the world's top tourism destinations, contributing significantly to economic growth, employment generation, and cultural exchange on a global scale.



% Share of India's ITA in World & Asia and the Pacific Region






Percentage Share of Major Countries of the World and India in International Tourist Arrivasl in 2019, 2022 and 2023





Monthwise Foreign Tourist Arrivals in India, 2019,2022 & 2023




Percentage share of Top 10 Countries for FTAs in India 2023



Monthwise FEE from Tourism in Rs. crore 2019, 2022, 2023



Month wise FEES from tourism in US\$ Billion during 2022-2023



Gender wise distribution of FTAs and INDs








Purpose wise FTAs from ASEAN






Gender wise distribution of FTAs and INDs

Gender wise distribution of FTAs and INDs






Gender wise distribution of FTAs and INDs
