#### EXPLORING NEW TOURIST DESTINATIONS

#### 3173 SHRI SANT BALBIR SINGH:

Will the Minister of **TOURISM** be pleased to state:

- (a) the specific efforts Government is making to promote tourism in Punjab;
- (b) whether there are any recent or upcoming projects aimed at enhancing the State's tourism infrastructure or promoting its cultural heritage;
- (c) whether the Ministry is exploring new or lesser-known places in Punjab and across the country to attract more tourists in the future;
- (d) the steps being taken to identify and develop these new destinations; and
- (e) the measures being taken to promote sustainable tourism in the country, particularly in regions with high tourist footfall like Punjab?

#### **ANSWER**

#### THE MINISTER OF TOURISM

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (e): Development and promotion of tourist destinations and products is primarily undertaken by the respective State Government/Union Territory (UT) Administration. The Ministry of Tourism through its central sector schemes of 'Swadesh Darshan (SD)', 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' complements the efforts of tourism infrastructure development in the country by extending financial assistance to the State Governments/UT Administrations including the State of Punjab.

Ministry has revamped Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourism destinations following a destination & tourist centric approach.

The Government of India under the guidelines for Special Assistance to States for Capital Investment (SASCI) for Development of Iconic Tourist Centres has approved one project in the State of Punjab.

The Ministry under the aforesaid schemes promote and develop various tourist destinations including the lesser-known destinations across the country. The details of projects sanctioned under the aforesaid schemes for the State of Punjab are **Annexed.** 

Receiving proposals from the State Governments/UT Administrations/Central Agencies for financial assistance for tourism projects is a continuous process. The proposals received are examined with reference to the prescribed guidelines and financial assistance is extended for such projects subject to fulfilment of the stipulated conditions and availability of funds.

The Ministry of Tourism has formulated a National Strategy for Sustainable Tourism, emphasizing environmental sustainability and the protection of biodiversity, to ensure that tourism development does not harm natural and cultural resources. Ministry of Tourism under its 'Travel for LiFE' Initiative encourages tourists and tourism businesses to adopt responsible tourism practices, promoting sustainability in destinations with high tourist footfall.
