### **BEACH TOURISM IN ODISHA**

### 3184 SHRI SUBHASISH KHUNTIA:

Will the Minister of **TOURISM** be pleased to state:

- (a) the steps being taken to promote beach tourism in Odisha, focusing on Puri, Gopalpur, and Chandipur beaches;
- (b) the measures to ensure cleanliness and safety at Odisha's beaches under the Blue Flag Certification initiative;
- (c) the funds allocated for developing beach tourism infrastructure in the State; and
- (d) whether the Ministry's plans to introduce water sports and recreational activities to attract more tourists?

### **ANSWER**

#### THE MINISTER OF TOURISM

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (d): Development, promotion and upkeep of tourist destinations and products, including beaches is undertaken by the respective State Government/Union Territory (UT) Administration. The Ministry complements the efforts of States/UTs by promoting various tourism products of the country through various initiatives.

The Ministry of Tourism through its central sector schemes of 'Swadesh Darshan', 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' extends financial assistance to the State Governments/UT Administrations for tourism infrastructure development in the country .The details of projects sanctioned under the Coastal Circuit of Swadesh Darshan Scheme are given at Annexure.

Environmental Sustainability is a key pillar in the National Strategy for Sustainable Tourism formulated by the Ministry. In line with the strategy, Travel for LiFE programme has been initiated to promote sustainable tourism in the country and to encourage tourists and tourism businesses to adopt sustainable tourism practices.

The Swadesh Darshan Scheme of the Ministry has been revamped as Swadesh Darshan 2.0 with the objective to develop sustainable and responsible tourism destinations following a tourist & destination centric approach. The Scheme encourages adoption of principles of sustainable tourism including environmental sustainability, socio-cultural sustainability and economic sustainability.
