- (a) whether any provision has been made by the Ministry to provide financial assistance to the States under Swadesh Darshan scheme and PRASHAD (Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive) scheme;
- (b) if so, the details thereof;
- (c) the main objective of the Ministry to develop the himalayan circuit under the Swadesh Darshan scheme; and
- (d) the funds allocated for the scheme to develop himalayan circuit?

ANSWER

THE MINISTER OF TOURISM

(a) to (d): Ministry of Tourism through its central sector schemes of 'Swadesh Darshan (SD)' and 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' complements the efforts of tourism infrastructure development in the country by extending financial assistance to the State Governments/UT Administrations.

Ministry of Tourism has revamped the Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD 2.0) with the objective to develop sustainable and responsible tourism destinations, following a destination & tourist-centric approach.

The Ministry of Tourism launched its Swadesh Darshan scheme (SDS) in the year 2014-15 with the objective to develop thematic circuits in the country, to augment tourism facilities in the country thereby promoting culture and heritage of the country, enhancing tourist attractiveness in a sustainable manner, creating awareness among the local communities about the importance of tourism, creating employment through active involvement of local communities etc. Seven projects were sanctioned under the Himalayan Circuit Theme of Swadesh Darshan Scheme. Details of the projects under the Himalayn Circuit Theme are **Annexed**.
