#### **DEKHO APNA DESH INITIATIVE**

## 3798. SHRI HARIBHAI PATEL:

#### Will the Minister of TOURISM be pleased to state:

- (a) the details of the activities that have been undertaken under Dekho Apna Desh to showcase India's diverse tourism destinations and products since January 2022, State-wise;
- (b) the details of the Government's collaboration with private stakeholders, Public Sector Undertakings and State Governments to offer tour programmes, packages and tools for both domestic and foreign tourists under said initiative;
- (c) the details of the mechanism are in place to evaluate the success of Dekho Apna Desh campaign and the manner in which these metrics being used to shape future tourism policies;
- (d) the details of the estimated economic impact of the aforementioned campaign on the local economies of less visited tourist destinations in the country; and
- (e) whether the Government has carved out detailed plans to sustain and build upon the successes of said campaign to further boost domestic tourism in the coming years, if so, the details thereof?

#### **ANSWER**

### THE MINISTER OF TOURISM (SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (e): The Ministry of Tourism had launched the Dekho Apna Desh initiative in January 2020 for promotion of domestic tourism in the country. Under this initiative, the Ministry promotes tourism destinations and products of India through various activities such as Webinars, Quiz, Pledge, Seminars, Tourism Promotional Events, Fam tours, Roadshows, Website, Social media etc.

Under this initiative, Ministry has launched Dekho Apna Desh People's Choice poll to engage with citizens to identify most preferred tourist attractions in the country.

Ministry of Tourism has launched the revamped version of www.incredibleindia.gov.in, wherein information pertaining to various Tour programmes, package tours are being provided in collaboration with stakeholders.

Increased Domestic Tourist visits to various destinations, under this initiative, is expected to boost local economies, create employment opportunities, and support hospitality services, thereby promoting sustainable tourism growth.
