## DEVELOPMENT OF BUDDHIST CIRCUIT IN GUJARAT

### 1427 SHRI NARHARI AMIN:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government is aware of the initiative taken by Government of Gujarat to develop a Buddhist Circuit across 12 heritage sites, including Devni Mori in Aravalli District, under the Swadesh Darshan 2.0 scheme, whether the Ministry has reviewed the ₹653 crore proposal submitted for Devni Mori's development;
- (b) the details of the Centre-State funding share for this project under SD 2.0, and whether similar proposals from other States have been considered or approved; and
- (c) the current status of land acquisition and infrastructure development across these 12 sites in Gujarat?

#### **ANSWER**

#### THE MINISTER OF TOURISM

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (c): Development and promotion of tourist destinations and tourism products is primarily undertaken by the respective State Government/Union Territory (UT) Administration. The Ministry of Tourism with the idea of develop thematic circuits in the country launched Swadesh Darshan (SD), a central sector scheme, in 2014-15 and sanctioned 76 projects for ₹5290.30 Crore till 2018-19 including 3 projects in the state of Gujarat which included 1 project in Buddhist Circuit covering 12 sites. The details of the projects sanctioned under SD scheme in Gujarat is at **Annexure-I**.

Gujarat Government has informed that it submitted a revised project report for Devni Mori amounting to ₹653.15 Crore to the Ministry of Tourism in November, 2018. However, post 2018-19, the Swadesh Darshan scheme was under review. The Ministry of Tourism vide its communications issued in March, 2021 and November, 2021 to the State Governments/UT Administrations informed that while the scheme is under review, the proposal submitted by them are deemed returned.

The Ministry of Tourism further revamped the scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable tourist destinations. The State Government of Gujarat submitted its State Perspective Plan and proposed tourist destinations including Devni Mori for consideration under Swadesh Darshan. The Ministry of Tourism under SD2.0 identified 'Dholavira' and 'Dwarka'. Swadesh Darshan 2.0 is a central sector scheme under which 100% funds are sanctioned by the Ministry of Tourism. Accordingly, the Ministry of Tourism has sanctioned 52 projects under SD2.0 in the country, the details of which is at **Annexure-II**.

The Ministry of Tourism also sanctioned the following projects in 2024-25 in Gujarat under 'Challenge Based Destination Development (CBDD), a sub-scheme of Swadesh Darshan:

In addition, Government of India under its initiative for 'Special Assistance to States for Capital Investment (SASCI)' has sanctioned the following projects in Gujarat in 2024-25:

As per the scheme guidelines of Swadesh Darshan 2.0, land acquisition for development is a non-admissible component for funding.

State Government of Gujarat has informed that for development Devni Mori site a total of approximately 206 hectares of land is required as per the initial master plan. Out of this, 28 hectares are already in possession. It has further been informed that in the financial year 2023–24, the Tourism Department of Government of Gujarat has made a budgetary provision under the new item "Iconic Destination Development" including development of Devni Mori.
