IDPMS FOR TOURISM IN KONKAN

2215# SHRI DHAIRYASHIL MOHAN PATIL:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government proposes to implement an Integrated Digital Project Management System (IDPMS) for coastal tourism projects in the Konkan region of Maharashtra;
- (b) if not, the platforms presently available for real-time monitoring of tourism initiatives in Konkan, including beach development, coastal heritage sites and marine tourism facilities; and
- (c) the steps proposed by Government to expedite pending tourism initiatives in the ecologically sensitive Konkan coastal region and to ensure optimal utilisation of funds?

ANSWER

THE MINISTER OF TOURISM

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (c): The Ministry of Tourism has not implemented an Integrated Digital Project Management System (IDPMS) for coastal tourism projects in the Konkan region of Maharashtra. Development of tourism is primarily undertaken by the concerned State Governments (SGs)/Union Territory Administrations (UTAs). However, the Ministry under its various schemes sanctions projects on receipt of the project proposal from the State Governments (SGs)/Union Territory Administrations (UTAs), adherence to the scheme guidelines, availability of funds, assessment of project proposal etc. The Ministry of Tourism used a dashboard for management of projects under Swadesh Darshan scheme. Further, the Ministry of Tourism revamped this scheme as Swadesh Darshan 2.0 (SD2.0). The guidelines for SD2.0 envisage setting up an online system to monitor the progress of the programme.

Projects under its various schemes such as Swadesh Darshan (SD), Swadesh Darshan 2.0 (SD2.0), Challenge Based Destination Development (CBDD), a sub-scheme of Swadesh Darshan, Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD) and Assistance to Central Agencies (ACA) for Tourism Infrastructure Development are sanctioned by the Ministry of Tourism in the country including Konkan region to develop tourism infrastructure and create tourism experiences. In addition, the Government has also approved projects under 'Special Assistance to States for Capital Investment (SASCI)' schemes in the country to create iconic destinations. The necessary clearances for undertaking the projects including those in eco-sensitive regions is obtained by the concerned State Government. The funds in respect of the sanctioned projects is released for implementation in instalments as per the guidelines and other instructions issued from time to time. The details of the projects sanctioned by the Ministry in SD, SD2.0, CBDD, PRASHAD, ACA and SASCI schemes in the states of Goa, Karnataka and Maharasthra including Konkan region is **Annexed**.
