RESTORATION AND PROMOTION OF RURAL HERITAGE SITES

2220 SMT. GEETA ALIAS CHANDRAPRABHA:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government plans to support restoration and promotion of lesser-known temple clusters and heritage sites across India;
- (b) the details of initiatives in Uttar Pradesh to link such sites to state cultural tourism circuits, including support for home-stays and craft stalls managed by women Self Help Groups; and
- (c) whether Government will promote restoration and tourism around Auraiya's Badi Devi and Mahadev temples and support women-led home-stays and craft stalls at these sites?

ANSWER

THE MINISTER OF TOURISM

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a): The Development and promotion of tourist destinations is undertaken by the respective State Government/Union Territory (UT) Administration. The Ministry of Tourism complements the efforts of States/UTs by developing and promoting various tourism products, including promotion of lesser-known temple clusters and heritage sites across India through various schemes and initiatives.

As per the information received from The Archaeological Survey of India (ASI), conservation and maintenance works including provision of amenities like drinking water, toilet blocks, pathways etc. of protected monuments/sites are taken up under the jurisdiction of ASI. Conservation and maintenance of monuments/sites is a continuous process and is taken up as per the need of the monuments and availability of resources.

(b): The Ministry of Tourism through its ongoing schemes of Swadesh Darshan, 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' has extended financial assistance for developing tourism related infrastructure in the country including the State of Uttar Pradesh. The details of projects sanctioned in Uttar Pradesh under the various schemes of the Ministry are given in the Annexure.

Further, the Government of India has approved the Pradhan Mantri Janjatiya Unnat Gram Abhiyan for development of homestays with the objective of improving the socio-economic condition of tribal communities.

(c): No proposal is under the consideration of the Ministry of Tourism for tourism infrastructure development around Auraiya's Badi Devi and Mahadev temples, Uttar Pradesh.
