#### HERITAGE & CULTURAL SITES IN GUJARAT AND MAHARASHTRA

# 622 DR. MEDHA VISHRAM KULKARNI: SHRI BABUBHAI JESANGBHAI DESAI:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has identified historic and cultural locations in Gujarat & Maharashtra under the Swadesh Darshan or PRASHAD schemes for integrated tourism development;
- (b) if so, the details of projects approved, including names of sites, funds allocated, and expected timelines for completion;
- (c) whether Government is coordinating with Archaeological Survey of India (ASI) to ensure that tourism promotion efforts do not compromise heritage preservation; and
- (d) the specific steps taken to promote local handicrafts, folk arts, and traditional cultural festivals in heritage clusters of Gujarat and Pune, with a view to strengthening community- based tourism and cultural livelihoods?

#### **ANSWER**

#### THE MINISTER OF TOURISM

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (d): Development and promotion of tourist destinations and tourism products is primarily undertaken by the respective State Government/Union Territory (UT) Administration. However, the Ministry of Tourism through its central sector schemes of 'Swadesh Darshan(SD)', Swadesh Darshan 2.0 (SD2.0), 'Challenge Based Destination Development (CBDD)' – a sub-scheme of Swadesh Darshan and 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' schemes complements the efforts of tourism infrastructure development by extending financial assistance to the State Governments/UT Administrations subject to availability of funds, adherence to scheme guidelines, and submission of Detailed Project Reports (DPRs) by the State Governments. The Ministry of Tourism under the above-mentioned schemes has provided financial assistance to the States of Gujarat and Maharashtra for development of tourism projects that includes historic and cultural locations in the states and has assigned the completion date as 31.03.2026. Details of the projects sanctioned in the above-mentioned schemes in the State of Maharashtra and Gujarat is annexed.

The Ministry of Tourism and the concerned State Governments also regularly co-ordinate with Archaeological Survey of India (ASI) on various issues pertaining to project design and implementation including requisite permissions.

The Ministry of Tourism as part of its ongoing promotional activities regularly promotes various tourism destinations and products of the country including Cultural and Community based tourism in the international and domestic markets through social media, promotional websites, events etc.
