COASTAL TOURISM CIRCUIT IN ANDHRA PRADESH

Will the Minister of **TOURISM** be pleased to state:

- (a) the details of Government projects proposed, under construction and presently working for coastal tourism circuit in Andhra Pradesh;
- (b) the details regarding the hotspots identified as part of the coastal tourism circuit of Andhra Pradesh and their development over the past five years;
- (c) the details of funds allocated and utilised over the last five years for the development of coastal tourism circuit in Andhra Pradesh, project-wise; and
- (d) whether Government has undertaken any campaigns to raise awareness regarding coastal tourism circuit in Andhra Pradesh, if so, the details thereof, and if not, the reasons therefor?

(a) to (d): Development and Promotion of tourist destinations and tourism products is primarily undertaken by the respective State Government/Union Territory (UT) Administration. However, the Ministry of Tourism through its central sector schemes of 'Swadesh Darshan(SD)', Swadesh Darshan 2.0 (SD2.0)', 'Challenge Based Destination Development (CBDD)' – a subscheme of Swadesh Darshan and 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' complements the efforts of tourism infrastructure development by extending financial assistance to the State Governments/UT Administrations; subject to availability of funds, adherence to scheme guidelines, and submission of Detailed Project Reports (DPRs) by the State Government etc.

In addition, Government of India under its initiative for 'Special Assistance to States for Capital Investment (SASCI)' has also provided financial assistance to the States for development of tourism projects.

The details of the projects sanctioned in the State of Andhra Pradesh under above mentioned schemes is annexed.

The Ministry of Tourism as part of its ongoing promotional activities regularly promotes various tourism destinations and products of the country including such endeavours in the international and domestic markets through social media, promotional websites, events etc.
