#### TOURISM PROJECTS IN KERALA

#### 1422 SHRI ABDUL WAHAB:

Will the Minister of **TOURISM** be pleased to state:

- (a) the details of tourism <u>projects</u> sanctioned for Kerala during the last five years;
- (b) the current status of each sanctioned project;
- (c) whether any new projects are under consideration during the current financial year;
- (d) the funds allocated to Kerala under various tourism development schemes during the last five years;
- (e) the year-wise and scheme-wise details of funds released; and
- (f) the funds utilized by the State Government, along with the reasons for any under-utilization?

#### **ANSWER**

### THE MINISTER OF TOURISM

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) to (f): Development of tourist destinations and tourism products are primarily undertaken by the concerned State Government (SG)/Union Territory Administration (UTA). However, the Ministry of Tourism through its central sector schemes of 'Swadesh Darshan (SD)', 'Swadesh Darshan 2.0 (SD2.0)', 'Challenge Based Destination Development (CBDD)' – a sub-scheme of SD2.0, 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies (ACA) for Tourism Infrastructure Development' complements the efforts of tourism infrastructure development by extending financial assistance to the State Governments/UT Administrations/Central Agencies; subject to adherence to scheme guidelines, submission of Detailed Project Reports (DPRs), availability of funds, inter-se priority etc.

In addition, Government of India under its initiative for 'Special Assistance to States for Capital Investment (SASCI)' has also provided financial assistance to the States for development of tourism related projects.

Presently there is no new proposal under consideration for sanctioning of projects in the state of Kerala under the above-mentioned schemes.

The details of projects sanctioned during the last five years under aforesaid schemes by the Ministry of Tourism in the state of Kerala along with released/ authorized, utilized and current status are **annexed**.
