REVIEWING TOURISM DEVELOPMENT SCHEMES

293 SMT. RAJANI ASHOKRAO PATIL:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has reviewed the implementation of central tourism development schemes across the country;
- (b) the details of infrastructure created under flagship programmes such as Swadesh Darshan, PRASAD and Dekho Apna Desh, State-wise and project-wise;
- (c) the utilisation levels, visitor footfall and operational status of such facilities;
- (d) the coordination mechanisms in place with State Governments and local authorities for promotion, maintenance and service delivery; and
- (e) the reasons why investments under the schemes have not consistently yielded the expected increase in tourist inflows and the steps proposed to enhance accessibility, marketing and overall effectiveness of tourism infrastructure?

STATEMENT IN REPLY TO PARTS (a) TO (e) OF RAJYA SABHA STARRED QUESTION NO.293 ANSWERED ON 19.03.2026 REGARDING REVIEWING TOURISM DEVELOPMENT SCHEMES RAISED BY SMT. RAJANI ASHOKRAO PATIL

(a) to (e): While development of tourism infrastructure is primarily undertaken by the concerned State Government (SG)/UT Administration (UTAs), the Ministry of Tourism under its tourism development related schemes such as Swadesh Darshan (SD), Swadesh Darshan 2.0 (SD2.0), Challenge Based Destination Development(CBDD)- an initiative under SD scheme, Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD) etc. provides financial assistance to SGs/UTAs for development of tourism infrastructure and amenities in the country on receipt of the project proposals from State Governments/UT Administrations, in synergy with the scheme guidelines, Government directions, availability of funds, inter-se priority etc.

Accordingly, the Ministry of Tourism has sanctioned 76 projects under SD for Rs.5290.33 Crore, 53 projects under SD2.0 for Rs.2208.31 Crore, 38 projects under CBDD for Rs.697.94 Crore and 54 projects under PRASHAD schemes for Rs.1726.74 Crore, the details of which is **annexed**. A range of components which may enhance tourism facilitation at the destinations are considered for sanctioning, as per project requirement including those related to tourism core products, tourism activities, safety, sanitation, connectivity, parking, general site development, soft interventions etc.

Operation and Management of the assets created through the financial assistance provided under the above-mentioned schemes is the responsibility of the concerned State Government/ UT Administration. The Ministry of Tourism regularly encourages the SGs /UTAs and concerned agencies to ensure robust O&M of completed projects so as to increase footfall, generate local employment and enhance overall tourist satisfaction.

In addition, the Ministry of Tourism has developed a Program Management Information System (PMIS) for its destination-related schemes to ensure effective monitoring of sanctioned projects. Furthermore, the Ministry regularly conducts review meetings with State Governments and Union Territory Administrations at different levels to facilitate completion of projects sanctioned under different schemes and to guide them on issues, if any.

Dekho Apna Desh initiative aims to raise awareness of India's rich heritage and culture, foster national pride, and encourage extensive domestic tourism. Under this initiative, Ministry of Tourism has organized webinars about different lesser-known destinations, quiz contests and other competitions both online and offline. Several domestic promotional events are also organised in association with tourism stakeholders.
